

HEARING OFFICER ORDER

On August 10, 2010, all parties participated in a telephonic status conference with the hearing officer. The petitioner stated that they are awaiting proposed permit language from the respondent. Respondent's motion for an extension of time to file the record, filed July 30, 2010, was also addressed. By agreement, respondent's motion was granted and the record in this matter is now due to be filed on or before October 1, 2010. Finally, the petitioner stated that it will file an additional 45 day waiver of the statutory decision deadline.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on September 23, 2010, at 10:00 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




