**HEARING OFFICER ORDER**

On September 1, 2010, the parties were scheduled to participate in a telephone status conference. The hearing officer was unable to attend. At the June 15, 2010 status conference, it was agreed that complainant would have 60 days to file a response to any dispositive motion filed by respondents.

On July 13, 2010, respondent Fairmount Park filed motions for summary judgment and motions to dismiss. It is unclear whether the remaining respondents will also file dispositive motions. As agreed on June 15, 2010, complainant's response to Fairmount Park was due September 13, 2010. Complainant's attorney requested more time which the hearing officer agreed to grant if Fairmount Park did not object. However, Fairmount Park did object, and the request for additional time was never granted.

If complainant seeks a deadline extension to respond, it must file a written motion for extension of time, and respondents will have 14 days to respond. Otherwise, complainant should file the response with a motion for leave to file *instanter*.

The parties are directed to participate in a telephone status conference with the hearing officer at 11:00 a.m. on December 6, 2010.
