

HEARING OFFICER ORDER

On September 16, 2010, all parties participated in a telephonic status conference with the hearing officer. The parties stated that they are still discussing language revisions in the stipulation and proposal for settlement (stipulation). The parties were directed to have a face-to-face meeting at Alpine Automotive to discuss the revisions prior to the next status conference.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on September 30, 2010, at 12:00 p.m. The telephonic conference must be initiated by the complainant, but each party is nonetheless responsible for their own appearance. At the conference, the parties must be prepared to discuss the status of the settlement discussions. If, however, a stipulation is filed prior to the next status conference, the conference will be cancelled without further notice.

IT IS SO ORDERED.




