**HEARING OFFICER ORDER**


On November 3, 2010, all parties participated in a telephonic status conference with the hearing officer. The parties stated that it appears this appeal will settle in the near future.

If, however, a motion to voluntarily dismiss is filed prior to the next status conference, the conference will be cancelled without further notice.


