HEARING OFFICER ORDER


On November 24, 2010, all parties participated in a telephonic status conference with the hearing officer. The parties have discussed further a possible settlement in this matter and referring to the Board's procedural rules. Respondent's attorney will also review stipulations and proposals for settlement found in PCB 10-36, PCB 9-10 and PCB 8-76.

The parties are again advised to visit the Board's website, www.ipcb.state.il.us, to research additional stipulations and proposals for settlement in other similar citizen enforcement cases, and to review the Board's procedural rules.

Should a resolution not be reached by the next telephonic status conference, hearing dates will be selected.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on January 20, 2011, at 12:00 p.m. The telephonic conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




