

**HEARING OFFICER ORDER**

On December 14, 2010, the petitioners informed the hearing officer that they anticipate a motion to voluntarily dismiss will be filed in the near future but that further discussion is needed. The petitioners also stated that they will file an additional waiver of the statutory decision deadline.

The parties are directed to participate in a telephonic status conference with the hearing officer on March 3, 2011, at 11:30 p.m. The status must be initiated by the petitioners, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a motion to voluntarily dismiss is filed prior to the next status conference, the conference will be cancelled without further order.


