
**HEARING OFFICER ORDER**

On February 8, 2011, all parties participated in a telephonic status conference with the hearing officer. The parties stated that depositions have been on-going. The complainant requested that a hearing date be scheduled. To that end, a hearing in the above-captioned case is scheduled for May 12, 2011. The time and location will be noted in the notice of hearing.

Further, the parties anticipate no more than 2 witnesses that will be testifying at the hearing. Any pre-hearing motions, including motions in *limine*, are due to be filed on or before April 4, 2011. Responses are due to be filed on or before April 15, 2011.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on March 17, 2011, at 9:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


