

(1) On November 9, 2009, Illinois EPA issued an Administrative Citation to Respondent Larry M. Ison (“Respondent”), based on an inspection conducted on September 14, 2009.


(2) On December 16, 2009, Respondent filed a Petition for Review contesting this Administrative Citation.


