

MOTION TO AMEND PROPOSAL

NOW COMES the Illinois Environmental Protection Agency ("Illinois EPA") by one of its attorneys, Kimberly A. Geving, and pursuant to 35 Ill. Adm. Code 101.500 and 101.502 moves the hearing officer in this matter to accept an amendment to the Illinois EPA's proposal via Errata Sheet Number 5.

In support of its motion, the Illinois EPA asserts that its Toxicity Assessment Unit has been in the process of reviewing the toxicological data for the Tiered Approach to Corrective Action Objectives ("TACO"- 35 Ill. Adm. Code 742) chemicals in order to update the list of toxicity values that is posted on the Illinois EPA's Bureau of Land webpage. During this review it was noted that the U.S.EPA has retired the chronic Reference Dose that had been posted in its Provisional Peer Reviewed Toxicity Values ("PPRTVs") for Di-n-octyl phthalate. As discussed on page 3 of Dr. Hornshaw's written testimony in support of the proposed amendments to Part 620 in this docket R08-18, the Toxicity Assessment Unit was aware that U.S.EPA retires the PPRTVs after a certain period of time but had made a decision to continue using retired PPRTVs instead of evaluating other sources of toxicity values for a chemical. However, after further internal discussion and discussions with U.S.EPA staff, that decision has been reversed and the

Toxicity Assessment Unit now does not use retired PPRTVs. There being no other toxicity values for Di-n-octyl phthalate, the Toxicity Assessment Unit inquired of U.S.EPA what was the status of review for this chemical and was told that is was their intention to issue a new PPRTV by the end of the federal fiscal year. Thus, there currently are no toxicity values available for Di-n-octyl phthalate, and the Illinois EPA therefore recommends removing this chemical from the proposed groundwater standards

WHEREFORE, the Illinois EPA requests that the hearing officer grant its motion and accept the changes made in Errata Sheet Number 5 prior to moving to First Notice.
