PETITION FOR HEARING TO CONTEST SITE LOCATION APPROVAL

Petitioner Solid Waste Agency of Northern Cook County ("SWANCC") by Mayer, Brown, Rowe & Maw, its attorneys, respectfully requests a hearing to contest the decision of the City of Des Plaines, Illinois ("City") approving the siting of the proposed Disposal Management Systems, Inc. ("DMS") Transfer Facility ("DMS Facility"). In support of this Petition, SWANCC states as follows:

- 1. This Petition is filed pursuant to Section 40.1(b) of the Illinois Environmental Protection Act (the "Act") (415 ILCS 5/40.1).
- 2. DMS submitted a request for site location approval to the City of Des Plaines dated August 5, 2002. The DMS request proposes to locate a waste transfer station on what is described as a 200 ft by 200 ft facility site at 101-103 Sell Road in the City of Des Plaines, Illinois which is currently owned and operated by DMS as a construction and demolition debris recycling center. The existing recycling center was not required to obtain a permit issued by the Illinois Environmental Protection Agency because it handles only wastes which are at least 75% recyclable. DMS applied for pollution control facility siting approval under Section 39.2 of the

Act, but did not state the amount of waste anticipated to be handled or recycled by the proposed transfer station on a daily or annual basis.

- 3. On December 2, 2002, following service and publication of notice, a seven minute hearing was conducted on the DMS siting application by the City of Des Plaines City Council. No other public hearing was held on the DMS transfer station siting application.
- 4. SWANCC was the sole public participant in the December 2, 2002 hearing. As is reflected in the minutes of the December 2, 2002 City Council meeting, SWANCC's Executive Director Brooke Beal presented testimony on behalf of SWANCC at the December 2, 2002 hearing. Mr. Beal also filed written comments on behalf of SWANCC during the subsequent public comment period. A true and correct copy of the minutes of the December 2, 2002 City Council meeting is attached hereto as Exhibit 1. A true and correct copy of the written comments filed by SWANCC on December 31, 2002 is attached hereto as Exhibit 2.
- 5. On February 18, 2003, the City of Des Plaines City Council, by roll call vote and without issuing an "official written decision," approved the siting of the DMS Facility, without conditions, as is reflected in the attached minutes of the City Council meeting. A true and correct copy of the February 18, 2003 City Council Meeting Minutes approving the siting of the DMS Facility is attached hereto as Exhibit 3.
- 6. On March 26, 2003, the City issued its "official written decision" along with a signed Illinois EPA Certification Form (LPC-P8), a true and correct copy of which is attached hereto. (Exhibit 4.)
 - 7. Section 107.204 of the Board's procedural rules governing siting appeals states:

 "A petition for review must be filed within 35 days after the local siting authority's action to approve or disapprove siting. Action means the local

government's official written decision granting or denying local siting approval pursuant to Section 39.2(e) of the Act" [emphasis added]¹

- 8. SWANCC's petition in this matter is timely filed within 35 days following the issuance of the City's March 26, 2003 "official written decision." ²
- 9. SWANCC is an Illinois not-for-profit unit of local government which was formed in 1988 under the Illinois Intergovernmental Cooperation Act. Its membership includes 23 Cook County municipalities. SWANCC participated in the public hearing conducted by the City of

The Section 104.204 requirement that the period for filing a petition commences on the date of the "official written decision" is consistent with Section 39.2 (e) which requires that a the local siting bodies decisions "are to be in writing, specifying the reasons for the decision, such reasons to be in conformance with subsection (a) of this Section." The requirement for a written decision before a decision becomes reviewable is also consistent with well established case law. See WMI v. IPCB, 145 Ill. 2d 345, 585 NE2d 606 (Ill. S. Ct. 1992) (While "final action" for purposes of meeting a deadline for administration action could occur without written findings, "we do not necessarily conclude that [such action] was final and appealable for purposes of review."); Reinhardt v. Board of Education of Alton, 61 Ill. 2d 101, 329 NE2d 219 (Ill. S.Ct. 1965) (A decision by an administrative agency must contain findings to make possible a judicial review of the agency's findings.)

² That the March 26, 2003 letter constitutes not only the "official written decision," but also the City's only written decision in this matter can be discerned from the several facts. First, in March 2003 SWANCC filed a Freedom of Information Act (FOIA) request with the City requesting the City's "final written decision." The City responded with a March 21, 2003 memorandum which provided the minutes of the February 18, 2003 City Council Meeting, the Certification of Siting Approval (LPC-PA8), and stated: "A letter will be sent to Disposal Management Systems, Inc. the week of March 24, 2003, along with the Certification, describing the conditions of approval. A copy will be sent to SWANCC." A true and correct copy of a March 21, 2003 memorandum is attached hereto as Exhibit 5. No other documents were provided in response to SWANCC's request for the City's "final written decision." See Affidavit attached hereto as Exhibit 6. Furthermore, the March 26, 2003 letter is the only City document which states the five conditions upon which the City's approval is stated to be contingent. Also, apparently the LPC-PA8 form accompanying the March 26, 2003 letter, was redone for the "official written decision." It is dated March 25, 2003.

Des Plaines on December 2, 2002, and therefore has standing to contest this siting approval pursuant to Section 40.1 (b) of the Act.

- 10. SWANCC contests and objects to the City of Des Plaines' decision to approve the siting of the DMS Facility because the siting process and procedures used by the City of Des Plaines in reaching that decision were fundamentally unfair.
- 11. SWANCC further contests the City of Des Plaines' siting approval because it is wholly unsupported by the record and is against the manifest weight of the evidence.
- 12. SWANCC further contests the City of Des Plaines siting approval because its siting procedures failed to produce a sufficient record for review and otherwise failed to meet the requirements of the Act.

WHEREFORE, SWANCC respectfully requests that the Board enter an order (a) setting for hearing this contest of the City of Des Plaines' siting approval decision, (b) reversing the City of Des Plaines' siting approval decision, and (c) providing such other and further relief as the Board deems appropriate.

PUBLIC HEÀRING/ TRANSFER STATION/101-103 SELL RD.: MINUTES OF THE PUBLIC HEARING HELD IN THE ELEANOR ROHRBACH MEMORIAL COUNCIL CHAMBERS, DES PLAINES CIVIC CENTER, MONDAY, DECEMBER 2, 2002

CALL TO ORDER:

Mayor Arredia called the Public Hearing to order at 7:12 p.m. The Public Hearing was being held pursuant to legal notice to obtain public comment on the application by Disposal Management Systems, Inc., For a Transfer Station Permit for a facility to be located at 101-103 Sell Road.

DISCUSSION:

Mr. C. Brooke Beal, Executive Director, Solid Waste Agency of Northern Cook County, 1616 E. Golf Road, Des Plaines, addressed the City Council stating their opposition to this request; they have not demonstrated a need; there are other places that could accept this material.

Petitioner Rick Anderson, Disposal Management Systems, Inc., addressed the City Council stating that this facility serves a great need for the surrounding area; they recycle construction debris; very few facilities do that; this facility is located and operated in a manner



The following comments are submitted in response to the transfer station proposed to be located at 101-103 Sell Road in Des Plaines, Illinois. The facility is proposed by Disposal Management Systems, Inc. ("DMS"), which currently operates a recycling center for construction and demolition debris at the proposed site. SWANCC has reviewed the documents comprising the Application for local siting approval per Section 39.2 of the Illinois Environmental Protection Act (the "Act"), and believes that the applicant has <u>not</u> demonstrated compliance with the nine criteria set forth by the Act. The Application is grossly inadequate and lacks critical information for making any determination regarding the suitability of the site for use as a solid waste transfer station. Therefore, SWANCC strongly recommends that the City of Des Plaines deny this application for local siting approval.

The Solid Waste Agency of Northern Cook County ("SWANCC") is experienced in the operations of solid waste transfer facilities, and is knowledgeable of the process for obtaining local siting approval in Illinois. SWANCC was formed in 1988 to manage the solid waste needs of its 23 member towns. SWANCC developed and adopted a long-term solid waste management plan in 1991, and has since worked to implement a balanced and environmentally safe program of solid waste management. SWANCC owns and administers the operating contract for the Wheeling Township Transfer Station, an 82,000-square foot state-of-the-art facility located in Glenview.

Evaluation of the Application

DMS is requesting approval to convert its existing construction and demolition ("C&D") debris recycling facility into a solid waste transfer station. The DMS application for local siting approval states that the reason for the proposed conversion is to allow the facility to accommodate loads of C&D debris containing less than 75 percent recyclable materials. For reference, Section 22.38 of the Act requires that facilities accepting exclusively general C&D debris for transfer shall



limit the percentage of incoming non-recyclable general C&D debris to 25 percent or less of the total incoming general C&D debris, as calculated on a daily basis. Solid waste transfer stations are not subject to this limit. DMS claims that the change in status from a C&D transfer/recycling facility to a solid waste transfer facility is the only proposed change to the existing facility, and therefore no modifications to the design or operations of the current facility are warranted.

The citizens of the City of Des Plaines should be advised that while DMS commits at this time to accept only C&D debris, the facility would conceivably be approved to accept all municipal solid waste (i.e., refuse or garbage), including waste from residential and commercial sources, in the future. Even if the City were to special condition its approval to restrict waste acceptance to solely C&D debris, this condition could be modified in the future without any further public process or consideration of the nine criteria. In addition, the Act provides that siting approval may be transferred to subsequent owners or operators, enabling others to develop the property for uses other than those proposed by DMS. Section 39.2 (e-5) of the Act states:

Siting approval obtained pursuant to this Section is transferrable and may be transferred to a subsequent owner or operator. In the event that siting approval has been transferred to a subsequent owner or operator, that subsequent owner or operator assumes and takes subject to any an all conditions imposed upon the prior owner or operator by the county board of the county or governing body of the municipality pursuant to subsection (e). However, any such conditions imposed pursuant to this Section may be modified by agreement between subsequent owner or operator and the appropriate county board or governing body. Further, in the event that siting approval obtained pursuant to this Section has been transferred to a subsequent owner or operator, that subsequent owner or operator assumes all rights and obligations and takes the facility subject to any and all terms and conditions of any existing host agreement between the prior owner or operator and the appropriate county board or governing body. (emphasis added)

For these reasons, the fullest level of compliance with the criteria set forth by the Act should be expected of any applicant requesting approval for a pollution control facility. As is discussed below, the Applicant has failed to provide even minimal documentation of compliance with statutory criteria of Section 39.2. Approval of DMS' application would lower the bar not only on the current application, but on any future applications as well.

Compliance with Section 39.2 of the Act

All new pollution control facilities (including transfer stations) proposed to be located in Illinois are subject to the requirements for local siting approval established by Section 39.2 of the Act. Nine criteria are set forth by Section 39.2 (a), which are the exclusive factors which the City of Des Plaines may consider in determining whether to grant siting approval. Section 39.2 (a) requires applicants for local siting approval to submit sufficient details describing the proposed facility to demonstrate compliance with the nine criteria, and stipulates that local siting approval shall be granted only if the proposed facility meets the criteria.

The application submitted by DMS consists solely of the following documents: a four-page narrative description of the facility; a partially completed copy of IEPA form LPC-PA8 (Certification of Siting Approval); and a plat of survey and topography. No expert witness testimony was presented at the public hearing on December 2, 2002 to further describe the design and operation of the proposed facility. Indeed, the only testimony presented was by SWANCC and, on rebuttal, by an owner of DMS, in which the owner agreed with the comments of SWANCC. This record clearly does not demonstrate compliance with the nine criteria of Section 39.2.

Criterion 1 - The facility is necessary to accommodate the waste needs of the area it is intended to serve.

As an initial matter, DMS has not identified a service area for the proposed facility, beyond stating that "this facility serves a great need for the surrounding area". No documentary evidence was presented in the record to indicate whether "surrounding area" means two feet, two miles or 20 miles. Because the service area is not defined, the City has no basis to evaluate compliance with Criterion 1.

Furthermore, DMS has not demonstrated that the facility is necessary to accommodate the waste needs of the intended service area. DMS justifies the need for the facility solely on the following observations:

- Recycling C&D debris will save landfill space;
- Operating the facility will improve the quality of life of citizens in the area;
- Recycling C&D debris will eliminate the need for construction contractors to travel to Elgin to obtain gravel; and,
- There are very few facilities that recycle C&D debris.



DMS has not presented any evidence, however, to support these observations. For instance, DMS does not present a list of aggregate producers to demonstrate that the only alternative source of gravel (aside from its proposed outlet for recovered concrete in Elk Grove Village) is located in Elgin.

Moreover, DMS argues that there are few other facilities that are capable of providing C&D recycling service. SWANCC is aware of a number of facilities in the area that provide this service, including:

- Groot Recycling and Disposal (transfer station located about 1/4 mile southwest of the proposed facility)
- · American Wood (C&D processing facility located in Hoffman Estates)
- Vulcan Materials (located in Elk Grove Village)
- Orange Crush (located in Chicago about ½ mile southwest of the proposed facility, as well as locations in Skokie and Wheeling)
- DuPage Materials (located in Elmhurst)
 - Crush Crete (located in Addision)

Finally, DMS has not demonstrated that its objectives cannot be met under their existing permit for the recycling facility. DMS appears to believe that each load which enters their facility must contain 75 percent or more recyclable materials. This is not true. The requirement under Section 22.38 (b.2) of the Act is that the facility shall "limit the percentage of incoming non-recyclable general construction or demolition debris to 25% or less of the total incoming general construction or demolition debris, as calculated on a daily basis." DMS presents no data on the projected amount of material to be handled, and therefore has not demonstrated a need that it cannot meet its recycling objectives through its existing permit.


Criterion 2 - The facility is so designed, located and proposed to be operated that the public health, safety and welfare will be protected.

DMS has not demonstrated that the facility is designed, located and proposed to be operated in a manner which will protect the public health, safety and welfare. The application merely states that the recycling facility has been operating for two years while being inspected by the IEPA, and since no changes are proposed, the criterion has been met. Clearly, however, a significant change is being proposed — since the modified facility would accept loads with less than 75 percent recyclables, the average daily quantity of waste handled at the facility would increase. No evidence is provided, however, to indicate the magnitude of the increase and whether the facility is capable of handling increased volumes.



The only drawing provided in the application is an undated plat of survey with handwritten notes, which is barely legible and contains no graphic scale. In order to adequately demonstrate compliance with this criterion, substantial additional information would be required regarding the facility's location, design, and plan of operations as described below.

Location



- Nearest residentially zoned property and its distance to the subject site to demonstrate compliance with Section 22.14 of the Act. Section 22.14 requires that within counties of at least 3,000,000 inhabitants no person may establish a transfer station within 1,000 feet of the nearest property zoned for primarily residential uses. If the facility is located within 10 contiguous acres of property utilized primarily for industrial uses, the facility may be located within 1,000 feet, but no closer than 800 feet from the nearest property zoned primarily for residential uses.;
- 100-year flood plain (refer to discussion under Criterion 4);
- Jurisdictional waters or wetlands, to confirm compliance with Section 404 of the Clean Water Act;
- Historic, architectural or archaeological resources,
 - Threatened or endangered species;

Design

A detailed description of the design of the facility is necessary to evaluate if the public health, safety, and welfare will be protected. Detailed plans should be provided, prepared to scale and in CAD or equivalent quality, showing the existing site conditions, proposed site conditions, traffic movements, and building floor plans. In addition, a description of the location, size, and design of the following transfer station features should be provided:

- Entrance, access roads, and interior circulation drives;
- · Scale and scale house;
 - Transfer station building:
- Waste tipping floor;
- Waste sorting and/or processing areas;
- Waste or recyclables storage areas;



- Waste loading bays;
- Vehicle queuing lanes;
- Security features such as fencing and gates;
- · Employee and visitor parking areas;
- · Utilities;
- Stormwater management structures;
- Fire control systems;
- Lighting;
- · Signage; and,
- Landscaping.

In addition, DMS notes in their response to Criterion 5 that a containment dike exists around the waste sorting operation. The nature of this dike needs to be more thoroughly described, including location, size, purpose, and method of treatment and/or discharge.

Operations

A plan of operations for the transfer station facility should be provided, which includes information on the following:

- Waste types;
- · Waste quantity projections;
- Methods for transferring waste;
- Demonstration that facility can accommodate projected waste quantity without causing backups onto exterior roadways or unsafe site conditions;
- · Equipment needs;
- Personnel needs;
- Hours of operation;
- Cleaning procedures;
- Methods to control nuisances such as dust, noise, odors, litter, and vectors;
- · Communication system;
- Record keeping system; and,
 - Vehicle fueling procedures.

DMS intends to accept loads with a lower recyclables content -- i.e., a higher content of non-recyclable solid waste. DMS does not indicate how long the increased volume of non-recyclable solid waste materials will remain on-site prior to transport to a disposal facility. Moreover, DMS does not indicate the types and amounts of waste that will be stored at the facility or the duration that they will be stored,



beyond stating "because of the small size of this facility, we cannot and do not store large amounts of any one material for long period of time." As was noted before, the volume of material handled at the site will likely increase, because incremental loads with less than 75 percent recyclables will be handled. Although DMS has acknowledged that it is a small facility, it has not demonstrated that its "small" facility can safely accommodate additional waste volumes.

Criterion 3 - The facility is located so as to minimize incompatibility with the character of the surrounding area and to minimize the effect on the value of the surrounding property.

DMS has not demonstrated that the facility is located so as to minimize incompatibility with the character of the surrounding area and to minimize the effect on the value of the surrounding property. Additional documentation (drawings, maps, and photographs) is warranted to fully characterize the land-uses in the surrounding area. A zoning map should be provided for the areas within a half-mile to mile radius of the site. In addition, any site features such as fencing and landscaping that may serve to screen operations from adjacent properties should be designed and/or identified.

Criterion 4 - The facility is located outside the boundary of the 100 year flood plain or the site is flood-proofed.

DMS has not demonstrated that the facility is located outside the boundary of the 100 year flood plain or that the site is flood-proofed. The application merely states that the facility is not located within the flood plain, without any supporting documentation. The appropriate panel of the Cook County Flood Insurance Rate Map (FIRM), published by the Federal Emergency Management Agency (FEMA), should be utilized in conjunction with a site topographic survey to determine the location of the 100 year flood plain. At a minimum, the application should include copies of such maps with the site location identified.

Criterion 5 - The plan of operations for the facility is designed to minimize the danger to the surrounding area from fire, spills, or other operational accidents.


DMS has not demonstrated that the plan of operations for the facility is designed to minimize the danger to the surrounding area from fire, spills, or other operational accidents. In addition to the items identified under Criterion 2 as critical components of the facility's operating plan, the following items should be addressed to demonstrate compliance with this criterion:

Employee training program;

Fire control and prevention mechanisms;



- Spill prevention and response plan;
- Loading checking program (to prevent unauthorized materials from being accepted by the facility):
- Site security measures;
- Emergency response procedures; and,
 - Operational contingency plans.



DMS has not demonstrated that the traffic patterns to or from the facility are so designed as to minimize the impact on existing traffic flows. The statement by DMS that traffic flows are not expected to change appreciably is not sufficient to demonstrate compliance with this criterion. A traffic study should be prepared by an experienced transportation engineer and include at a minimum the following information:

- Identification of the roadway network to be used to access the proposed transfer station;
- Analysis of the traffic generated by the facility, including number and type of vehicle per each hour of operating day and the direction by which traffic will enter and exit the facility;
- Assessment of the existing roadway network, including traffic volumes, approved or planned developments or roadway improvements, and accident data;
 - Evaluation of the impact of the site generated traffic on the existing roadways, including compliance with weight restrictions and the projected level of service and vehicular delay at critical intersections;
- Review of proposed site plan in conjunction with the projected traffic volumes and known turning radii of vehicles utilizing the transfer station. Confirm that the proposed entrance configuration and interior traffic movements will adequately and safely accommodate waste collection and transfer vehicles.


Criterion 7 - If the facility will be treating, storing or disposing of hazardous waste, an emergency response plan exists for the facility which includes notification, containment and evacuation procedures to be used in case of an accidental release.

DMS proposes that the facility will not accept or store hazardous waste. However, DMS' conclusion that an emergency response plan is not required is untrue. Such a plan is required (under Criterion 2 or Criterion 5 if not Criterion 7) to address the handling of asbestos materials which may be delivered to the facility, or fuel spills from trucks and operating equipment.



Criterion 8 - If the facility is to be located in a county where the county board has adopted a solid waste management plan consistent with the planning requirements of the Local Solid Waste Disposal Act or the Solid Waste Planning and Recycling Act, the facility is consistent with that plan.

DMS has not demonstrated that the proposed transfer station facility is consistent with the applicable solid waste management plan. Cook County adopted a Solid Waste Management Plan in 1996, and updated the Plan in 2000. While the application states that recycling is an important goal of the County, DMS has not demonstrated a comprehensive understanding of the Plan. Additional information is warranted to demonstrate compliance with the Plan, including:



Demonstration that the proposed facility meets each of the objectives identified.

Criterion 9 - If the facility will be located within a regulated recharge area, any applicable requirements specified by the Board for such areas have been met.

Regulated recharge areas are established by the Illinois Pollution Control Board to protect areas where the groundwater is particularly susceptible to contamination due to local geology. To properly demonstrate compliance with this criterion, DMS should provide evidence from the Illinois Environmental Protection Agency (IEPA) that the facility is not located within a regulated recharge area.

Other Requirements of Section 39.2 of the Act

Section 39.2 (b) of the Act requires the Applicant to provide written notice of the request for location approval (via personal service or registered mail) to property owners within 250 feet of the subject property and to members of the General Assembly from the legislative district in which the proposed facility is located. In addition, notice must be published in a newspaper of general circulation in Cook County.

Section 39.2 (d) of the Act requires that notice of the public hearing be provided (via certified mail) to members of the General Assembly from the legislative district in which the proposed facility is located, to the governing authority of every municipality contiguous to the proposed site or contiguous to Des Plaines, to Cook County, and to the IEPA. Notice must also be published in a newspaper of general circulation in Cook County.



The notices are required to be submitted no later than 14 days prior to the filing of the request for siting approval or the date of public hearing, respectively. No evidence has been provided that all of the required notices were issued in compliance with the Act.



Summary

In summary, DMS has not provided sufficient information to demonstrate compliance with Section 39.2 of the Act. The application is clearly lacking in critical details, making it impossible to properly evaluate it for use as a transfer station facility.

--a landscape buffer be constructed along the entire Hills Street frontage consisting of a 6-8 foot high opaque wall built of face brick and/or other approved material; the wall shall be set back 5-10 feet from the petitioner's property line along Hills Avenue and contain trees, shrubs and grass and/or plant ground cover.

The petitioner, Dan Pontarelli, Pontarelli Builders, 7001 W. Higgins Road, Chicago, IL 60656, addressed the Committee of the Whole and answered questions from the aldermen; he wants to attract the highest quality of retailers for that corner.

Alderman Becker stated that he is concerned that there is not enough of a buffer between this project and the neighbors; this developer should be encouraged but the project needs more work; he is not ready to vote this evening.

Alderman Beauvais stated that there have been no meetings with the residents in the area; we should not piece meal this property; that corner is such an eyesore; the access to Hills Avenue is a big issue with her; how will the traffic flow?; we need to know what we will be putting on this site.

Mr. Pontarelli stated that he will work with the City to "work out the bugs."

Alderman Sayad thanked Mr. Pontarelli for his interest in this corner; he should meet with the Ward alderman and maybe the Economic Development Commission; he should come back with a solid plan.

Alderman Brookman stated that she did some research with the County and these lots are both legal and buildable; we need to clear this up.

Alderman Becker stated that the Staff and Mr. Pontarelli with meet and work on these concerns of the aldermen.

Both Alderman Smith and Argus agreed that the rezoning should be granted; the project will come back to the aldermen at another time. Mr. Pontarelli stated that the rezoning will help him get retailers.




On February 18, 2003, the Des Plaines City Council approved local siting for a transfer station at Disposal Management Systems (DMS), Inc. located at 103 Sell Road in Des Plaines, IL. The facility has provided the City adequate documents and has satisfied the criteria under the Illinois Environmental Protection Act ("ACT") Title X, Section 39.2. Disposal Management Systems, Inc. may proceed in applying to the Illinois Environmental Protection Agency (IEPA) to obtain a transfer station permit.

The City's approval is contingent upon the following conditions:

- Materials accepted and recycled shall be limited to construction and demolition debris (pallets, wood, concrete, cardboard, bricks, asphalt, steel, aluminum, and clean dirt/gravel/sand). Any other material (i.e. refuse, yard waste, etc.) accepted to the facility for disposal will void this approval and the facility will be under violation.
- 2. The approval shall only be for Disposal Management Systems, Inc. located at 103 Sell Road. If DMS re-locates to another location in Des Plaines, DMS must re-submit an application for the new location and provide any/all new documents.
- 3. DMS shall maintain record keeping of load volumes (in and out), contents, and destination.
- 4. DMS shall keep property clean and orderly and maintain safety and emergency requirements.
- 5. DMS shall keep operating hours as stated on the July 10, 2002 facility description correspondence. Daily hours are 5 AM to 5 PM.

The City is enclosing a signed and notarized IEPA Certification of Siting Approval (LPC-PA8) that was supplied with the original DMS application. Please provide us with a copy of your IEPA permit when you receive it.


