

**HEARING OFFICER ORDER**

On March 3, 2011, the petitioners informed the hearing officer that additional settlement documents are being reviewed and that the parties remain hopeful that a motion to voluntarily dismiss will be filed in the near future. The parties are directed to participate in a telephonic status conference with the hearing officer on June 9, 2011, at 11:30 p.m. The status must be initiated by the petitioners, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a motion to voluntarily dismiss is filed prior to the next status conference, the conference will be cancelled without further order.


