

Under Part 101, Subpart C, service may be effectuated by U.S. Mail or other mail delivery service, in person, by messenger, or by electronic transmission with approval from the Clerk of the Board or hearing officer. 35 Ill. Adm. Code 102.304(c); 101.302(d). Midwest Generation intends this waiver of service of documents in hard copy, subject to approval from the Clerk of the Board or hearing officer, to allow any participant or person serving a document in this rulemaking docket the option of serving Midwest Generation by electronic transmission, via email to the attorneys of record, rather than in hard copy.
