

HEARING OFFICER ORDER

On May 19, 2011, the petitioner informed the hearing officer that the parties continue to be involved with internal discussions regarding how to proceed and that the parties, including technical personnel, have met since the last telephonic status conference. The petitioner represented that it will file an additional 90 day waiver of the statutory decision deadline.

At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




