HEARING OFFICER ORDER

On May 19, 2011, a telephonic status conference was held. The complainant stated that it has committed to a one year flow monitoring and reviewing flow data. The complainant also stated that engineering proposals for the development of a sewer separation and storm water relief plan for the 55th Street location is being evaluated. The complainant stated that it is drafting an inter-governmental agreement for the respondents review, including a review by the high school that has yet to be added as a respondent.

Respondent Village of Hinsdale stated that subsequent the issuance of a construction and operating permit, all work at the Third and Princeton is completed.

Respondent DuPage County stated that they are reviewing a list of permitting requirements for locations in question that was given to them by the complainant.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on August 25, 2011, at 11:00 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. The complainant represented that it will notify the parties and the hearing officer of a call-in number prior to the next telephonic status conference. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
