RE: City of Springfield case - PCB 70-9

Hearings in the above case were held on November 16 through 19, 1970, at the Illinois State Fairgrounds, State of Illinois Building Auditorium, Springfield, Illinois. The hearings were completed at approximately 4:30 p.m. on the 19th.

The Agency was represented by Mr. Thomas Scheuneman, and the City of Springfield was represented by Mr. Walter Simhauser and Mr. I. J. Feuer. Attached are three lists:
