
HEARING OFFICER ORDER

On July 19, 2011, all parties participated in a telephonic status conference. Discussions centered on the second Joint Motion for Extension of Time filed on July 15, 2011. The parties request that respondent Illinois Environmental Protection Agency (Agency) filing of its recommendation be extended to August 15, 2011. Mot. at 2. The parties additionally request that the hearing scheduled for August 4, 2011, be cancelled and continued until a date that will be discussed. The parties represent that the additional time is needed to discuss issues raised in the petitioner's petition. Mot. at 2.

The parties were directed to file a written motion to cancel the hearing pursuant to Section 101.510 of the Board's procedural rules. Nonetheless, the hearing scheduled for August 4, 2011, is cancelled. The joint motion for an extension of time is granted to the extent that the Agency's recommendation is now due on or before August 15, 2011.

The parties or their legal representatives are directed to appear at a telephonic pre-hearing conference with the hearing officer on August 4, 2011, at 9:30 a.m. The telephonic conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


