

On August 25, 2011, the parties submitted an agreed proposed discovery schedule. The discovery schedule is accepted to the extent as follows. All written discovery must be served on or before October 15, 2011. All responses to the written discovery must be served on or before December 15, 2011. The parties must identify all non-expert witnesses and serve requests for admissions on or before January 15, 2012. All responses to requests for admissions must be served on or before February 15, 2012. The parties are to complete depositions of non-expert witnesses on or before March 31, 2012.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on October 20, 2011, at 11:00 a.m. The telephonic conference must be initiated by the complainants, but each party is nonetheless responsible for its own appearance. At the conference the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
