

NOW COMES the Complainant, the Illinois Environmental Protection Agency (“Illinois EPA”), by and through its attorney, Special Assistant Attorney General Michelle M. Ryan, pursuant to 35 Ill. Adm. Code 108.402, and respectfully states as follows:


- (1) On May 31, 2011, Illinois EPA issued an Administrative Citation to Respondents Thad and Linda Shafer, based on an inspection conducted on April 7, 2011.
- (2) On June 7, 2011, service was timely made on Respondent Thad Shafer.
- (3) Proof of service is not available for Respondent Linda Shafer. Upon further review, Illinois EPA has been unable to determine whether a person with this name exists or where service may be had upon such a person.
- (4) Because Respondent “Linda Shafer” was not timely served within 60 days as required by 415 ILCS 5/31.1(b), this Administrative Citation should be dismissed as to her.


