OBJECTION TO PETITIONER'S MOTION FOR LEAVE TO FILE SURREPLY

NOW COMES the Respondent, the Illinois Environmental Protection Agency ("Illinois EPA"), by one of its attorneys, Melanie A. Jarvis, Assistant Counsel and Special Assistant Attorney General, and, pursuant to 35 Ill. Adm. Code 101.500, 101.502, 101.616, and 101.622 hereby respectfully moves the Illinois Pollution Control Board ("Board") to DENY the Petitioner's Motion for Leave to File Surreply. In support of said motion, the Illinois EPA states as follows:

I. ARGUMENT

As the Illinois EPA has stated over and over again, this case is very simple and straight forward. It is a case where the relevant facts are not in dispute. Petitioner has repeatedly tried to throw in irrelevant issues to distract the Board from the clear issue at hand: Whether the Illinois EPA applied the correct deductible. The Illinois EPA has clearly and convincingly shown through its Motion for Summary Judgment that it did apply the correct deductible.

The facts and the law are uncontroverted. The only reason the Petitioner continues down this path with motion after motion, such as its latest incarnations entitled "Petitioner's Motion for Leave to File the Surreply" and the "Surreply", is simply because it really cannot meet its burden of proof to show that, based upon the Administrative Record, the Illinois EPA decision was made in error.
