SECOND NOTICE CHANGES

Agency: Pollution Control Board

Rulemaking: Air Quality Standards (35 Ill. Adm. Code 243; 34 Ill. Reg. 17537)

Changes:

1. In lines 125-126, 127-128, 142, 151-152 and 155, change "micrograms per cubic meter" to "µg/m³".
2. In lines 181-182, 185, 189 and 222, strike "micrograms per cubic meter" and add "µg/m³".
3. In line 193, strike "(1982)" and add "(incorporated by reference in Section 243.108)".
4. In lines 209 and 210, delete "Part".
5. In line 209, after "53" add "(incorporated by reference in Section 243.108)".
6. In line 210, after "53" add a period.
7. In line 231, change the comma to an opening parenthesis and change "of this Part" to a closing parenthesis.
8. In line 233, after "R" change the comma to an opening parenthesis.
9. In line 234, change "of this Part" to a closing parenthesis.
