
**HEARING OFFICER ORDER**

On November 15, 2011, a telephonic status conference was held. Respondent Zachary Isaac d/b/a Nu Shine Car Wash (NuShine) did not appear. The complainant stated that it and respondent Samuel Johnson (Johnson) have continued to have had productive discussions and that it is anticipated that a settlement will occur. By agreement, Johnson's answer is now due to be filed on or before January 26, 2011.

The complainant stated that it will likely file a motion for default as to NuShine. It is noted that NuShine has yet to file an appearance or answer.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on January 12, 2012, at 9:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




