**NOTICE OF WAIVER OF 120-DAY DECISION DEADLINE**

NOW COMES Petitioner, KCBX TERMINALS COMPANY (“KCBX”), a North Dakota corporation, by and through its attorneys, HODGE DWYER & DRIVER, pursuant to 35 Ill. Admin. Code § 101.308(c)(2), and hereby agrees to waive the statutory 120-day decision deadline for final action by the Illinois Pollution Control Board (“Board”) in this proceeding until June 7, 2012. In support of this Notice, KCBX states as follows:

1. On April 5, 2011, KCBX filed its Response to Respondent’s Motion to Consolidate with Case No. PCB 11-43, stating it had no objection to the consolidation of KCBX Terminals Company v. IEPA, PCB 10-110 (“PCB 10-110”) and the case of KCBX Terminals Company v. IEPA, PCB 11-43 (“PCB 11-43”) provided only that no delay resulted from the consolidation.
2. In light of such consolidation, KCBX voluntarily agreed to waive the statutory 120-day decision deadline in PCB 10-110 until August 18, 2011, which was also the current decision deadline in PCB 11-43.
3. On May 24, 2011, KCBX filed a Notice of Waiver of 120-Day Decision Deadline until September 22, 2011.

4. On June 3, 2011, KCBX filed a Notice of Waiver of 120-Day Decision Deadline until October 6, 2011.

5. On June 10, 2011, KCBX filed a Notice of Waiver of 120-Day Decision Deadline until November 3, 2011.

6. On July 28, 2011, KCBX filed a Notice of Waiver of 120-Day Decision Deadline until December 6, 2011.

7. On September 9, 2011, KCBX filed a Notice of Waiver of 120-Day Decision Deadline until January 5, 2012.

8. On October 12, 2011, KCBX filed a Notice of Waiver of 120-Day Decision Deadline until February 16, 2012.

9. On November 14, 2011, KCBX filed a Notice of Waiver of 120-Day Decision Deadline until April 5, 2012.

10. On December 21, 2011, KCBX filed a Notice of Waiver of 120-Day Decision Deadline until May 3, 2012.

11. The current statutory decision deadline for this consolidated matter is May 3, 2012.

12. KCBX hereby voluntarily agrees to waive the statutory 120-day decision deadline until June 7, 2012, in order to conduct settlement negotiations in this matter.

WHEREFORE, Petitioner, KCBX TERMINALS COMPANY, prays that the Illinois Pollution Control Board accept this waiver of the statutory 120-day decision deadline until June 7, 2012, for final action on KCBX's appeal of the "Construction

Permit – Revised” and KCBX’s appeal of the “Revised FESOP” issued to it by the Illinois Environmental Protection Agency.
