
**HEARING OFFICER ORDER**

The respondent Fredrick K. Slayton stated that it will forward a remediation proposal to the complainant within the next 7 days.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on May 24, 2012, at 11:15 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




