**NOTICE OF PROPOSED STIPULATION AND PROPOSAL FOR SETTLEMENT OF ENFORCEMENT CASE**

The Attorney General has brought a case against **Adolf M. Lo and Renee C. Lo d/b/a Lo Farms**, for violation of State pollution control rules. On March 30, 2012, the parties filed a proposed settlement agreement. The parties agree that a hearing is unnecessary, and in accordance with State law, have requested that the settlement be adopted without holding a public hearing.

Any person desiring that a hearing be held may demand a public hearing in this case by filing a written hearing request with the Illinois Pollution Control Board within 21 days after the publication of this notice. The hearing request should refer to **People of the State of Illinois v. Adolf M. Lo and Renee C.
