NOTICE OF PROPOSED STIPULATION AND PROPOSAL FOR SETTLEMENT OF ENFORCEMENT CASE

The Attorney General has brought a case against Roxana Landfill, Inc., an Illinois corporation, Midwest Sanitary Service, Inc., an Illinois corporation (Midwest), WRB Refining LP, a Delaware limited partnership (WRB), and ConocoPhillips Company, a Delaware corporation (ConocoPhillips), for violation of State pollution control rules. On April 23, 2012, the parties filed two separate proposed settlement agreements. A settlement agreement on behalf of Midwest only was filed. A second separate agreement on behalf of ConocoPhillips and WRB was also filed. The parties agree that a hearing is unnecessary, and in accordance with State law, have requested that the settlement be adopted without holding a public hearing as to any issues involving ConocoPhillips, WRB and Midwest. Roxana Landfill, Inc. was not a party to either agreement.

Any person desiring that a hearing be held may demand a public hearing in this case by filing a written hearing request with the Illinois Pollution Control Board within 21 days after the publication of this notice. The hearing request should refer to People of the State of Illinois v. Roxana Landfill, Inc., an Illinois corporation, Midwest Sanitary Service, Inc., an Illinois corporation, WRB Refining LP, a Delaware limited partnership, and ConocoPhillips Company, a Delaware corporation, PCB 12-123, and should be mailed to the Clerk of the Illinois Pollution Control Board, 100 West Randolph Street, Suite 11-500, Chicago, Illinois 60601.
