Dear Honorable Members of the Illinois Pollution Control Board,

I write to you today to share my support for Ameren Energy Resources (AER) and its request to extend the deadline for upgrading its energy stations to meet new state emission standards.

As the Parks & Recreation Superintendent for Robinson, I know that AER is an important proponent of our local economy. The Newton Energy Center currently employs 198 people, and these well-paying jobs boost the household income and spur economic development in our community. The plant is also an imperative source of property tax revenue (\$7,572,478.66 million in the 2010 tax year), which in turn supports essential public services like education and public safety.

I understand the interest for Illinois to adopt strict regulations. In fact, our community and AER support this direction as well.

However, in this time of economic hardship, AER does not have the financial resources to immediately meet the Illinois emission requirements.
