

NOW COMES the Complainant, the Illinois Environmental Protection Agency ("Illinois EPA"), by and through its attorney, Special Assistant Attorney General Michelle M. Ryan, pursuant to 35 Ill. Adm. Code 101.500, and respectfully states as follows:

(1) On July 28, 2010, Illinois EPA issued an Administrative Citation to Respondent, Karen L. Allen ("Respondent"), based on an inspection conducted on July 1, 2010.


(2) On August 19, 2010, Respondent filed a timely petition for review contesting this Administrative Citation.


