**NOTICE OF LIMITED WAIVER OF 120-DAY DECISION DEADLINE**

NOW COMES Petitioner, UNITED STATES STEEL CORPORATION (“Petitioner”), by and through its attorneys, HODGE DWYER & DRIVER, pursuant to 35 Ill. Admin. Code § 101.308(c)(2), hereby agrees to a limited waiver of the statutory 120-day decision deadline for final action by the Illinois Pollution Control Board (“Board”) in this proceeding until March 21, 2013. In support of this Notice, Petitioner states as follows:

1. On October 5, 2011, Petitioner filed a Petition for Review (“Petition”) of the Construction Permit issued to Petitioner by the Illinois Environmental Protection Agency (“Illinois EPA”) on August 31, 2011, for an emission control system for Petitioner’s basic oxygen process (“BOP”) furnaces at Petitioner’s integrated steel mill plant located in Granite City, Illinois.
2. On October 20, 2011, the Board accepted Petitioner’s Petition for hearing. Board Order, *United States Steel Corporation v. Illinois EPA*, PCB No. 12-54 (Ill.Pol.Control.Bd. Oct. 20, 2011).

3. The current statutory decision deadline for this matter is December 20, 2012.

4. Petitioner hereby voluntarily agrees to a limited waiver of the statutory 120-day decision deadline until March 21, 2013, in order to conduct settlement negotiations with Illinois EPA in this matter.

WHEREFORE, Petitioner, UNITED STATES STEEL CORPORATION, prays that the Illinois Pollution Control Board accept this limited waiver of the statutory 120-day decision deadline for final action on Petitioner's Petition for Review.
