

**HEARING OFFICER ORDER**

On September 25, 2012, a telephonic status conference was held. Respondent, Winnebago Landfill Company did not appear. Discussions centered on respondents' County of Winnebago and Winnebago County Board's motion for leave to file reduced number of copies of the record and an extension of time to file the record. Without objection, the motion was granted to the extent as follows. The County of Winnebago and the Winnebago County Board must file the original record, 2 copies and a thumb drive of the record (Respondents stated that the record was too voluminous to file the record as a CD). It was also agreed that the record due date is extended to September 28, 2012.

IT IS SO ORDERED.




