JURISDICTION

This Administrative Citation is issued pursuant to the authority vested in the Illinois Environmental Protection Agency by Section 31.1 of the Illinois Environmental Protection Act, 415 ILCS 5/31.1 (2010).

FACTS

- 1. That Kenneth Hails is the current owner ("Respondent") of a property located at 14600 East Divide Road, in rural Texico, Jefferson County, Illinois. The property is commonly known to the Illinois Environmental Protection Agency as Texico/Hails, Kenneth (2).
- 2. That said facility is an open dump operating without an Illinois Environmental Protection Agency Operating Permit and is designated with Site Code No. 0818065009.
 - 3. That Respondent has owned said facility at all times pertinent hereto.
- 4. That on August 15, 2012, Garrison Gross of the Illinois Environmental Protection Agency's ("Illinois EPA") Marion Regional Office inspected the above-described facility. A copy of his inspection report setting forth the results of said inspection is attached hereto and made a part hereof.

5. That on 9-27-12, Illinois EPA sent this Administrative Citation via Certified Mail No. 7004 2510 0001 8588 37/0

VIOLATIONS

Based upon direct observations made by Garrison Gross during the course of his August 15, 2012 inspection of the above-named facility, the Illinois Environmental Protection Agency has determined that Respondent has violated the Illinois Environmental Protection Act (hereinafter, the "Act") as follows:

- (1) That Respondent caused or allowed the open dumping of waste in a manner resulting in litter, a violation of Section 21(p)(1) of the Act, 415 ILCS 5/21(p)(1) (2010).
- (2) That Respondent caused or allowed the open dumping of waste in a manner resulting in proliferation of disease vectors, a violation of Section 21(p)(5) of the Act, 415 ILCS 5/21(p)(5) (2010).
- (3) That Respondent caused or allowed standing or flowing liquid discharge from the dump site, a violation of Section 21(p)(6) of the Act, 415 ILCS 21(p)(6) (2010).
- (4) That Respondent caused or allowed the open dumping of waste in a manner resulting in deposition of general construction or demolition debris: or clean construction or demolition debris, a violation of Section 21(p)(7) of the Act, 415 ILCS 5/21(p)(7) (2010).

CIVIL PENALTY

Pursuant to Section 42(b)(4-5) of the Act, 415 ILCS 5/42(b)(4-5) (2010), Respondent is subject to a civil penalty of One Thousand Five Hundred Dollars (\$1,500.00) for each of the violations identified above, for a total of Six Thousand Dollars (\$6,000.00). If Respondent elects not to petition the Illinois Pollution Control Board, the statutory civil penalty specified above shall be due and payable no later than October 31, 2012 unless otherwise provided by order of the Illinois Pollution Control Board.

If Respondent elects to contest this Administrative Citation by petitioning the Illinois Pollution Control Board in accordance with Section 31.1 of the Act, 415 ILCS 5/31.1 (2010), and if the Illinois Pollution Control Board issues a finding of violation as alleged herein, after an adjudicatory hearing, Respondent shall be assessed the associated hearing costs incurred by the Illinois Environmental Protection Agency and the Illinois Pollution Control Board. Those hearing costs shall be assessed in addition to the One Thousand Five Hundred Dollar (\$1,500.00) statutory civil penalty for each violation.

Pursuant to Section 31.1(d)(1) of the Act, 415 ILCS 5/31.1(d)(1) (2010), if Respondent fails to petition or elects not to petition the Illinois Pollution Control Board for review of this Administrative Citation within thirty-five (35) days of the date of service, the Illinois Pollution Control Board shall adopt a final order, which shall include this Administrative Citation and findings of violation as alleged herein, and shall impose the statutory civil penalty specified above.

When payment is made, Respondent's check shall be made payable to the Illinois Environmental Protection Trust Fund and mailed to the attention of Fiscal Services, Illinois Environmental Protection Agency, 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276. Along with payment, Respondent shall complete and return the enclosed Remittance Form to ensure proper documentation of payment.

If any civil penalty and/or hearing costs are not paid within the time prescribed by order of the Illinois Pollution Control Board, interest on said penalty and/or hearing costs shall be assessed against the Respondent from the date payment is due up to and including the date that payment is received. The Office of the Illinois Attorney General may be requested to initiate proceedings against Respondent in Circuit Court to collect said penalty and/or hearing costs, plus any interest accrued.

PROCEDURE FOR CONTESTING THIS ADMINISTRATIVE CITATION

Respondent has the right to contest this Administrative Citation pursuant to and in accordance with Section 31.1 of the Act, 415 ILCS 5/31/1 (2010). If Respondent elects to contest this Administrative Citation, then Respondent shall file a signed Petition for Review, including a Notice of Filing, Certificate of Service, and Notice of Appearance, with the Clerk of the Illinois Pollution Control Board, State of Illinois Center, 100 West Randolph, Suite 11-500, Chicago, Illinois 60601. A copy of said Petition for Review shall be filed with the Illinois Environmental Protection Agency's Division of Legal Counsel at 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276. Section 31.1 of the Act provides that any Petition for Review shall be filed within thirty-five (35) days of the date of service of this Administrative Citation or the Illinois Pollution Control Board shall enter a default judgment against the Respondent.



Subject: Open Dump Site Inspection at Kenneth Hails Property

General Remarks: An Open Dump Site Inspection was conducted on Wednesday, August 15, 2012, at property owned by Kenneth Hails. Garrison Gross representing the Illinois EPA Bureau of Land conducted the inspection. The property is located at ~14600 East Divide Road, in rural Texico, Illinois 62889. The inspection was performed as a follow-up to a telephone complaint (C-12-072) alleging open dumping at the site. Weather conditions at the time of the inspection were clear skies, 77° F, with a light breeze; surface conditions were dry.

<u>Inspection Findings</u>: The inspection began at approximately 9:50 a.m. The site was initially observed from offsite. The surrounding property appeared to be used for agricultural purposes and consisted of open grassy fields and agricultural fields. An office trailer was located at the site. Large piles of landscape waste and construction / demolition debris were observed near overhead high voltage power lines. No one was present when I entered the property. I continued the inspection by walking and photographing the site.

Area A: A large pile of landscape waste was observed (photos 001 and 011). The pile measured approximately 200 feet long by 30 feet wide. The landscape waste did not appear to be generated onsite and it appeared as if a commercial landscape waste hauler was using the site for disposal purposes. The landscape waste consisted of leaves, branches, grass clippings and bagged material (photo 005). A few pallets and pieces of dimensional lumber were also observed. The waste pile was producing a strong odor similar to manure although no manure was observed. Evidence of leachate puddles was observed in two locations near the waste pile. One semi-dried puddle was located along East Divide Road and measured approximately 10 feet long by 2 feet wide (photo 012). The second semi-dried puddle measured approximately 10 feet long by 10 feet wide (photo 013). Numerous flies were observed swarming the landscape waste near the largest leachate puddle. Several piles of construction / demolition debris were also located in this area. The piles contained but were not limited to: dimensional lumber, paneling, drywall, bricks, and mortar (photos 002-004).

<u>Area B</u>: This area was located south of East Divide Road in an open grassy field. A large pile of landscape waste was observed (photo 006). The waste pile consisted of tree limbs, root balls and stumps. Approximately 40 cubic yards of construction / demolition debris were located in this area (photo 007). The debris consisted of dimensional lumber, paneling and drywall.

Area C: This area consisted of an office trailer and parking lot (photo 008). Several piles of construction / demolition debris and waste metal were open dumped along the northern edge of East Divide Road (photo 009). A collapsed building comprised of demolition debris was also observed in this area (photo 010).




Approximately 1500 cubic yards of landscape waste were observed at the site. Approximately 600 cubic yards of construction / demolition debris and metal wastes were located at the site. The inspection ended at approximately 10:10 a.m.

Additional Remarks: Information concerning property ownership was obtained through tax records from the Supervisor of Assessment's Office in Jefferson County. Tax bills are mailed to Kenneth Hails, 21606 North Hails Lane, Texico, Illinois, 62889. The property is referred to as parcel 03-09-400-011 and contains approximately 80 acres.






