PETITIONER'S POST-HEARING BRIEF

Now comes Petitioner, Martin Maggio ("Maggio"), by his attorneys, and hereby submits his Post-Hearing Brief in connection with his appeal of the Winnebago County Board's (the "County Board") approval of the Site Location Application ("Application") submitted by Winnebago Landfill Company, LLC ("WLC") for the expansion of WLC's existing municipal solid waste landfill located North of Edson Road and West of U.S. Interstate 39 in Southern Winnebago County, Illinois.

I. INTRODUCTION

Maggio filed the instant Appeal on August 15, 2012. This Board found that the Appeal was timely filed and accepted the Appeal via its Order of August 23, 2012. The Appeal was based on two grounds – that the County Board lacked jurisdiction to hear or rule on the Application because all persons entitled to notice had not been properly served, and that the proceedings before the County Board had been fundamentally unfair. After limited discovery, Maggio withdrew the fundamental fairness claim, and this Appeal now proceeds solely on the issue of the County Board's lack of jurisdiction. (Hearing Transcript, p. 6)

Focusing on the issue of jurisdiction, §39.2 of the Illinois Environmental Protection Act (the "Act"), 415 ILCS 5/39.2 provides:

(b) No later than 14 days before the date on which the county board or governing body of the municipality receives a request for site approval, the applicant shall cause written notice of such request **to be served** either in person or by registered mail, return receipt requested, on the owners of all property within the subject area not solely owned by the applicant, and on the owners of all property within 250 feet in each direction of the lot line of the subject property, said owners being such persons or entities which appear from the authentic tax records of the County in which such facility is to be located; provided, that the number of all feet occupied by all public roads, streets, alleys and other public ways shall be excluded in computing the 250 feet requirement; provided further, that in no event shall this requirement exceed 400 feet, including public streets, alleys and other public ways.

Such written notice shall also be served upon members of the General Assembly from the legislative district in which the proposed facility is located and shall be published in a newspaper of general circulation published in the county in which the site is located.

Such notice shall state the name and address of the applicant, the location of the proposed site, the nature and size of the development, the nature of the activity proposed, the probable life of the proposed activity, the date when the request for site approval will be submitted, and a description of the right of persons to comment on such request as hereafter provided. [Emphasis added]

It is well-settled that this pre-application notice provision constitutes a jurisdictional prerequisite to a siting authority's ability to consider a siting application. *Kane County Defenders, Inc. v. Pollution Control Board*, 139 Ill.App.3d 588, 592-593 (2nd Dist. 1985) Lack of jurisdiction results from either the failure to serve notice, or if notice is served less than 14 days before the application is filed. See *Browning-Ferris Industries of Illinois, Inc. v. Pollution Control Board*, 162 Ill. App. 3d 801, 805 (5th Dist.

1987); *Concerned Boone Citizens, Inc. v. M.I.G. Investments, Inc.*, 144 Ill.App.3d 334, 339 (2nd Dist.1986)

The facts in this matter are undisputed, and are the subject of a stipulation between the parties (the "Stipulation") admitted into the record of the hearing herein on December 4, 2012. (Stipulation, Hearing Exhibit 1, attached hereto as Exhibit 1; Hearing Transcript p. 9-10) With respect to the issue of the County Board's jurisdiction, the Stipulation confirms that, contrary to the requirements of §39.2(b) of the Act:

- Certified mail notices to all property owners entitled to notice pursuant to 415 ILCS 5/39.2(b) were placed in a U.S. Post Office box in Ottawa, Illinois on December 27, 2011.
- The certified mailings to certain of the persons to whom the pre-filing notices were mailed were not claimed, and were then returned to WLC's counsel by the U.S. Postal Service, with no certified mail return receipt "green card" having been executed.
- WLC made no further effort at serving those persons who did not claim their certified mail.
- The Application was filed with Winnebago County on January 17, 2012.
- Pre-filing notices to certain persons to whom they were mailed were not delivered until after January 3, 2012 (the 14th day before the filing of the Application).

(Stipulation, ¶¶3-7) It is with these stipulated facts in mind that WLC's failure to comply with §39.2(b), and the County Board's consequent lack of jurisdiction, must be addressed.

II. WLC FAILED TO SERVE ALL PERSONS ENTITLED TO PRE-APPLICATION NOTICE IN ACCORDANCE WITH THE REQUIREMENTS OF §39.2(b), AND THE COUNTY BOARD LACKED JURISDICTION TO DECIDE ON THE APPLICATION

This case is governed by *Ogle County Board on Behalf of County of Ogle v. Pollution Control Board*, 272 Ill.App.3d 184, 196 (2nd Dist. 1995), appeal denied *sub nom Ogle County Board v. Pollution Control Board*, 163 Ill.2d 563 (1995), where the court held that:

[T]he 'return receipt requested' provision of section 39.2(b) of the Act reflects the intent of the legislature to require actual receipt of the notice, as evidenced by the signing of the return receipt. *** Because the return receipts at issue in the case at bar were signed after the notice deadline had expired, we find that the notice did not comply with the requirements of section 39.2.

Ogle County is directly on point and has never been overruled by either the Second District Appellate Court or the Illinois Supreme Court. Nevertheless, in *City of Kankakee v. County of Kankakee*, 2003 WL 21995876, Slip Op. Cite at 14 (IPCB August 7, 2003), this Board stated that:

Waste Management argues that service by certified mail return receipt requested is sufficient notice based on the Supreme Court's ruling in *\$30,700 U.S. Currency*, which Waste Management asserts overruled the appellate court in *Ogle County*. Based on the ruling in *\$30,700 U.S. Currency*, Waste Management argues that Mr. Keller, Mr. Mehrer and Mr. Karlock were properly served. The Board has reviewed *Ogle County*, in which the appellate court ruled that actual receipt of prefiling notice was required to effectuate service under the Act, and the Supreme Court's decision in *\$30,700 U.S. Currency* in which the Supreme Court found mailing of certified mail return receipt requested was sufficient to satisfy notice requirements. Based on that review, the Board is convinced that the Supreme Court's decision in *\$30,700 U.S. Currency* **effectively overrules** the appellate court's decision in *Ogle County*. Thus, under Section 39.2(b) of the Act (415 ILCS 5/39.2(b)(2002)), an applicant can effect service by mailing the prefiling notice to property owners

certified mail return receipt and the service is proper upon mailing. [Emphasis added]

This Board's decision in *City of Kankakee* is flawed on several grounds.

First, this Board had no authority to find that *Ogle County* was "effectively" overruled. Administrative agencies like the Board are creatures of statute. As such, they have no inherent, general or common law powers. Rather, they only have the powers specifically conferred upon them by the legislature. *Granite City Division of National Steel Co. v. Illinois Pollution Control Board*, 155 Ill.2d 149, 171 (1993); *City of Chicago v. Fair Employment Practices Commission*, 65 Ill.2d 108, 113 (1976) In the same vein, an administrative agency lacks the authority to ignore any portion of its enabling statute. See *Eckman v. Board of Trustees for the Police Pension Fund*, 143 Ill.App.3d 757, 765 (2nd Dist. 1986) Any action or decision taken by an administrative agency in excess of or contrary to its authority is void. *Delgado v. Board of Election Commissioners of City of Chicago*, 224 Ill.2d 481, 485 (2007)

It is a fundamental precept of Illinois jurisprudence that the decisions of an appellate court are binding, and an appellate court's decision must therefore be followed. *Delgado* at 488 In the context of prior judicial construction of a statute, "*stare decisis* considerations are at their apex. *** Considerations of *stare decisis* weigh more heavily in the area of statutory construction...because such a departure...amounts to an amendment of the statute itself rather than simply a change in the thinking of the judiciary with respect to common law concepts which are properly under its control." *People v. Williams*, 235 Ill.2d 286, 295 (2009), quoting *Froud v. Celotex Corp.*, 98 Ill.2d 324, 336 (1983) See also *Neal v. United States*, 516 U.S. 284, 295-296 (1996)

This point is particularly important in the context of jurisdictional issues, like that raised by §39.2. Directly addressing the concept of “effective” overruling in this context, the U.S. Supreme Court in *Hohn v. U.S.*, 524 U.S. 236, 252-253 (1998) held:

This is not to say opinions passing on jurisdictional issues *sub silentio* may be said to have overruled an opinion addressing the issue directly. See, e.g., *United States v. More*, 3 Cranch 159, 172, 2 L.Ed. 397 (1805) (Marshall, C. J.). Our decisions remain binding precedent until we see fit to reconsider them, regardless of whether subsequent cases have raised doubts about their continuing vitality.

See also *Rodriguez de Quijas v. Shearson/American Express, Inc.*, 490 U.S. 477, 484 (1989) (“If a precedent of this Court has direct application in a case, yet appears to rest on reasons rejected in some other line of decisions, the Court of Appeals should follow the case which directly controls, leaving to this Court the prerogative of overruling its own decisions.”)

Simply stated, the Act does not grant this Board the authority to ignore or amend, “effectively” or otherwise, either the Act or binding appellate decisions – and particularly decisions regarding purely legal issues. “[A]n agency's decision on a question of law is not binding on a reviewing court. For example, an agency's interpretation of the meaning of the language of a statute constitutes a pure question of law. Thus, the court's review is independent and not deferential.” *Cinkus v. Village of Stickney Municipal Officers Electoral Board*, 228 Ill.2d 200, 210 (2008) See also *Exelon Corp. v. Department of Revenue*, 234 Ill.2d 266, 275 (2009) (Construction of a statute by an administrative agency has no binding effect – it is a pure question of law subject to *de novo* review by the appellate court.) The point is particularly applicable here, since any review of this case would be directed the Appellate Court for the Second District, which

also decided *Ogle County*. 415 ILCS 5/41(a) See also *Aleckson v. Village of Round Lake Park*, 176 Ill.2d 82, 92 (1997)

Moreover, resort to *People ex rel. Devine v. \$30,700.00 U.S. Currency*, 199 Ill.2d 142 (2002), the basis for this Board's decision in *City of Kankakee*, is misplaced. In the first instance, *U.S. Currency* dealt with a wholly different statute – the Drug Asset Forfeiture Procedure Act, 725 ILCS 150/1, *et seq.* (“DAFPA”) – and neither the Act, nor the specific service requirements of §39.2 of the Act, nor the *Ogle County* decision. This distinction is critical given the fundamental differences between the two statutes.

The *U.S. Currency* Court first described the purpose of DAFPA:

The Act is **a remedial civil sanction** enacted for the express purpose of deterring the rising incidence of the abuse and trafficking of substances prohibited by the Illinois Controlled Substance Act (720 ILCS 570/100 *et seq.* (West 2000)) and the Cannabis Control Act (720 ILCS 550/1 *et seq.* (West 2000)). See 725 ILCS 150/2 (West 2000). Forfeiture under the Act “encourages owners ‘to take care in managing their property and ensures that they will not permit that property to be used for illegal purposes.’ ” *In re P.S.*, 175 Ill.2d 79, 87, 221 Ill.Dec. 853, 676 N.E.2d 656 (1997), citing *United States v. Ursery*, 518 U.S. 267, 116 S.Ct. 2135, 135 L.Ed.2d 549 (1996). Thus, **the Act is designed to serve a remedial purpose and, therefore, is liberally construed to achieve that purpose.** 725 ILCS 150/ 13 (West 2000). [Emphasis added]

199 Ill.2d at 149 The Court then reviewed the notice provision in §4 of DAFPA, 725 ILCS 150/4:

Section 4 of the Act, entitled “ Notice to Owner or Interest Holder,” provides that, “[i]f the owner's or interest holder's name and current address are known, then [notice or service shall be given] by either personal service **or mailing** a copy of the notice by certified mail, return receipt requested, to that address.” 725 ILCS 150/4(A) (1) (West 2000). The Act requires notice by publication in the event the address or name of the owner or interest holder is unknown. 725 ILCS

150/4(A) (3) (West 2000). Owners or interest holders are obligated to advise the seizing agency of address changes that occur prior to the mailing of notice. 725 ILCS 150/4(A)(1) (West 2000) (“if an owner or interest holder's address changes prior to the effective date of the notice of pending forfeiture, the owner or interest holder shall promptly notify * * * of the change in address”). Individuals claiming an interest in the property subject to forfeiture may file a claim to the property within “45 days after the effective date of notice.” 725 ILCS 150/6(C)(1) (West 2000). Further, the Act provides when notice is effective: “**Notice served under this Act is effective upon** personal service, the last date of publication, or **the mailing of written notice**, whichever is earlier.” 725 ILCS 150/4(B) (West 2000). [Emphasis added]

Section 4 of DAFPA clearly establishes that notice is effective in any one of three ways, including either publication or “mailing”, in and of itself. This was the basis for the *U.S. Currency Court*'s ultimate ruling:

In light of the express language contained in section 4 of the Act, we hold that service of notice by mailing is perfected when the notice is deposited in the mail, provided the State complies with the mailing procedures set forth in the Act. Section 4(B) expressly states, “[n]otice served under this Act is effective upon * * * the mailing of written notice * * *.” 725 ILCS 150/4(B) (West 2000). **The meaning of this provision is clear and unambiguous.** The Act does not condition the effectiveness of notice upon receipt of the return receipt signed by the addressee, and this court will not rewrite the Act to create this requirement.

Claimants argue that the inclusion of the “return receipt” language implies that the legislature intended that notice would not be perfected unless and until the State receives the return receipt. This argument fails to consider the structure of section 4, which, when plainly read, supports another conclusion. Section 4(A) directs the State to issue notice of forfeiture proceedings by specific methods—personal service, publication, or postal delivery. Essentially, section 4(A) directs how notice shall be given, or by what means notice must be served. Where postal delivery is required, section 4(A) requires service by certified mail with a return receipt requested. In contrast, section 4(B) fixes when service is complete. Service is effective “upon personal

service, the last date of publication, or the *mailing of written notice*, whichever is earlier.” (Emphasis added.) 725 ILCS 150/4(B) (West 2000). The return receipt requirement is omitted from the “when” provision of section 4(B). [Emphasis added]

199 Ill.2d at 151 The distinction between the type of notice, and when notice is effective, has been applied in other contexts. See, e.g., *Zito v. Guttilla*, 176 Ill.App.3d 933, 937 (1st Dist. 1988) (Mere mailing of notice was sufficient where contract language expressly provided that “the mailing of a notice by registered or certified mail” shall constitute sufficient service. Additional language “return receipt requested” in the notice provision only indicated the type of mailing which was acceptable.)

In contrast, §39.2 expressly requires that the notice “be served”, and not merely “mailed”, and requires publication in addition to service. Relegating the requirement of service in §39.2 to one of mere mailing, absent express language to that effect (as in §4 of NAFPA), ignores the dramatic difference in the language of the two statutes. More to the point, it ignores the importance of the notice requirement in §39.2, and the reason why service of notice is jurisdictional:

[U]nder the statutes governing county board proceedings in such matters (Ill.Rev.Stat.1983, ch. 111½, par. 1039.2), the county board is required to hold a public hearing and develop a record upon which it must base its independent evaluation of the proposed landfill site. The legislature has charged the county board, rather than the PCB, with resolving the technical issues such as the public health ramifications of a landfill's design. (*City of East Peoria v. Illinois Pollution Control Board* (1983), 117 Ill.App.3d 673, 680, 72 Ill.Dec. 682, 452 N.E.2d 1378, appeal allowed.) This broad delegation of adjudicative power to the county board **clearly reflects a legislative understanding that the county board hearing, which presents the only opportunity for public comment on the proposed site, is the most critical stage of the landfill site approval process.** [Emphasis added]

Kane County Defenders, Inc. v. Pollution Control Board, supra, 139 Ill.App.3d at 592-593 See also *McLean County Disposal, Inc. v. County of McLean*, 207 Ill.App.3d 477, 480 (4th Dist. 1991); *Browning-Ferris Industries of Illinois, Inc. v. Illinois Pollution Control Board*, 162 Ill.App.3d 801, 806-807 (5th Dist. 1987)

The U.S. Circuit Court also recognized that the nature of NAFPA warranted a more permissive interpretation of the notice requirement:

Finally, we must also consider that the Act is remedial in nature; therefore, the Act warrants liberal construction to achieve the overall purpose of the statute. 725 ILCS 150/2, 13 (West 2000). The appellate court's holding, that the State must receive a return receipt signed by the addressee, fails to recognize the circumstances which often accompany forfeiture.

Conditioning the completion of notice upon receipt of the return receipt is a condition not expressed by the legislature, and given the realities of what often occurs in these cases, an obstacle to the enforcement of the Act. The statute provides for mailing of notice to the last known address of the owner or interest holder. **It does not condition this mailing upon the State's investigation into the accuracy of this information. In fact, it expresses the contrary: the owner or interest holder is obligated to notify the seizing agency of his or her change in address occurring prior to the mailing of notice.** 735 ILCS 150/4(A)(1) (West 2000). The appellate court's holding renders this obligation superfluous. See *Yang v. City of Chicago*, 195 Ill.2d 96, 106, 253 Ill.Dec. 418, 745 N.E.2d 541 (2001) (“[w]e construe a statute so that no term is rendered superfluous or meaningless, when the statute is examined as a whole”).

199 Ill.2d at 154-155

Section 39.2 of the Act imposes the opposite requirement – the applicant is obligated to determine the identity and location of persons entitled to notice “from the authentic tax records of the County in which such facility is to be located”. The statute

imposes all obligations on the applicant, not on the putative recipient, with the object of insuring participation by all persons entitled to notice. In this regard, the court in *McHenry County Landfill, Inc. v. Illinois E.P.A.*, 154 Ill.App.3d 89, 96 (2nd Dist. 1987) focused on the purpose of the Act, and specifically on §39.2:

The stated purpose of the Act is “to restore, protect and enhance the quality of the environment, and to assure that adverse effects upon the environment are fully considered and borne by those who cause them.” (Ill.Rev.Stat.1985, ch. 111 ½, par. 1002(b).) In addition, the supreme court has recognized the legislature's intent “to place decisions regarding the sites for landfills with local authorities.” (*E. & E. Hauling, Inc. v. Pollution Control Board* (1985), 107 Ill.2d 33, 42, 89 Ill.Dec. 821, 481 N.E.2d 664.)

Of particular relevance to the instant case, the Act also reflects a legislative finding “that in order to alleviate the burden on enforcement agencies, to assure that all interests are given a full hearing, and to increase public participation in the task of protecting the environment, private as well as governmental remedies must be provided....” 415 ILCS 5/2(a)(v) Finally, the Illinois General Assembly expressly mandated that, “The terms and provisions of this Act shall be liberally construed so as to effectuate the purposes of this Act....” 415 ILCS 5/2(c)

The court in *Kane County Defenders* also compared the service requirements in §39.2 to the notice requirement for permit appeals in §40(a) of the Act, 415 ILCS 5/40(a), which provides:

If the Agency refuses to grant or grants with conditions a permit under Section 39 of this Act, the applicant may, within 35 days, petition for a hearing before the Board to contest the decision of the Agency. The Board shall give 21 day notice to any person in the county where is located the facility in issue who has requested notice of enforcement proceedings and to each member of the General Assembly in whose legislative district that installation or property is

located; and shall publish that 21 day notice in a newspaper of general circulation in that county.

139 Ill.App.3d at 592 Contrasting this simple “give notice” requirement, the *Kane County* court found that the requirements of §39.2 are “more demanding at the county board phase of the process” [Emphasis added]. *Id.* at 593

It is also important to keep in mind an axiomatic principle of statutory construction recognized by the *U.S. Currency* Court – that a statute must be read as a whole so that no term is rendered superfluous or meaningless. See *Texaco–Cities Service Pipeline Co. v. McGaw*, 182 Ill.2d 262, 270 (1998) Section 39.2(b) of the Act specifies the contents of the required notice, including:

1. The name and address of the applicant;
2. The location of the proposed site;
3. The nature and size of the development;
4. The nature of the activity proposed;
5. The probable life of the proposed activity;
6. The date when the request for site approval will be submitted; and
7. A description of the right of persons to comment on such request as hereafter provided


All of these requirements, and particularly notification of the right of persons to participate in the siting process, are rendered wholly illusory if there is no assurance that persons on whom notice must be served are, in fact, served.

III. CONCLUSION

It is undisputed that persons entitled to notice from WLC did not receive notice, or received notice beyond the mandated service deadline. For all of the foregoing

reasons, the County Board lacked jurisdiction to consider or rule upon the Application,
and its decision must be reversed.

7. The Application was filed with Winnebago County on January 17, 2012.



AFFIDAVIT OF COMPLIANCE WITH 415 ILCS 5/39.2(b)

GEORGE MUELLER, being first duly sworn on oath, deposes and states as follows:

1. I am an attorney licensed to practice in the State of Illinois with my principal office located at 609 E. Etna Road, Ottawa, Illinois, 61350.

2. I am one of the attorneys for Winnebago Landfill Company, LLC, and it was my responsibility to prepare, publish and serve pre-filing notices as required in 415 ILCS 5/39.2(b).

3. 415 ILCS 5/39.2(b) requires that no later than fourteen (14) days prior to a request for location approval of a pollution control facility, the applicant shall cause written notice of such request to be served either in person or by registered mail, return receipt requested, on the owners of all property within the subject area not wholly owned by the applicant and on the owners of all property within 250 feet in each direction of the lot line of the subject property, said owners being such persons or entities which appear from the authentic tax records of the county in which such facility is to be located, provided, that the number of all feet occupied by all public roads, streets, alleys and other public

ways shall be excluded in computing the 250 feet requirement, provided further that in no event shall this requirement exceed 400 feet, including public streets, alleys and other public ways. Section 39.2(b) further provides that such notice shall be served upon members of the general assembly from the legislative district in which the proposed facility is located and shall be published in a newspaper of general circulation published in the county in which the site is located. Section 39.2(b) further provides that such notice shall state the name and address of the applicant, the location of the proposed site, the nature and size of the development, the nature of the activity proposed, the probable life of the proposed activity, the date when the request for site approval will be submitted, and a description of the right of persons to comment on such request.

4. The Notice prepared and served in connection with the aforesaid requirement is attached hereto and made a part hereof as Exhibit A. Said Notice conforms to the requirements of Section 39.2(B).

5. I identified the names and address of all members of the General Assembly from the legislative district in which the proposed facility is located by using information publically maintained and available on the Illinois General Assembly internet website www.ilga.gov.

6. I caused a copy of the Notice to be published in the Rockford Registered Star, a newspaper of general circulation in the county in which the application is pending on December 28, 2011. A copy of the actual publication and proof of publication is attached hereto and made a part hereof as Exhibit B.

7. On December 13, 2011, I searched the authentic tax records in Winnebago County and Ogle County to ascertain the names and addresses of all owners of the subject property and all other property within 400 feet of the subject property. In Winnebago County, I first visited the office of the Treasurer and was advised that the County Treasurer, the County Supervisor of Assessments, and the County Recorder jointly maintain a consolidated computer database of the authentic tax records of the County. I was told that this database is generally updated daily. I was also provided with plat books, section maps and line drawings which enabled me to accurately identify the parcel index numbers of properties in proximity to the subject property. I was provided access to a computer in the County Recorder's office to access the consolidated database of authentic records for the purpose of identifying owner names and addresses associated with the parcel identification numbers. The process in Ogle County was essentially the same, and County also has a consolidated computer database of official tax records maintained and updated on a daily basis. The only difference in the Ogle County process was that Ogle County also has a GIS department which maintains online maps from which the parcel identification numbers of adjoining properties could be identified without having to access hard copies of plat books or section maps.

8. Attached hereto and made a part hereof as Exhibit C is the full and complete list of all individuals and entities which were sent pre-filing Notice pursuant to 415 ILCS 5/39.2(b). This includes all owners of property and members of the General Assembly who were entitled to Notice.

9. On December 27, 2011, I caused the consolidated computer databases of official tax records in Winnebago County and Ogle County to be searched again to ascertain whether there had been any changes or additions since my previous search.

10. On December 26 and December 27, 2011, certified mail Notice was sent to all individuals and entities set forth on Exhibit C. Copies of the certified mail receipts for all of these Notices are attached hereto and made a part hereof as Exhibit D.

11. The siting application herein was filed on January 17, 2012.

12. All of the foregoing complies fully and completely with the pre-filing notice requirements of 415 ILCS 5/39.2(b).

YOU ARE HEREBY NOTIFIED, pursuant to Section 39.2(b) of the Illinois Environmental Protection Act ("the Act"), 415 ILCS 5/39.2(b), that the Applicant, Winnebago Landfill Company, LLC ("WLC"), whose address is 5450 Wansford Way, Suite 201, Rockford, IL., 61109, will file its request for siting approval for a new pollution control facility with the County of Winnebago, 404 Elm Street, Rockford, Illinois 61101, on January 17, 2012. In its request the Applicant will seek approval to site, construct, expand and operate the Winnebago Landfill located generally across from WLC's landfill office at 8403 Lindenwood Road, Rockford, Illinois 61109, east of Ill. Rte. 251, west of US Interstate 39 and north of Edson Rd. The Applicant will seek approval to laterally expand the existing sanitary landfill facility to the east.

The proposed expansion would increase the permitted disposal area (i.e., the waste footprint) from 196.81 acres to 419.19 acres on a total site of 797.387 acres (the present site being 433.47 acres). The proposed expansion would have a maximum height of 1002 feet msl.

The proposed facility would be a non-hazardous solid waste landfill. The Applicant will develop and operate a modern, secure sanitary landfill for the disposal of municipal solid waste and non-hazardous special waste, only as approved by the Illinois Environmental Protection Agency and other regulatory




