
Granting the variance can help sustain the positive impact of the company's operations on local communities and businesses and help preserve property tax revenues for education and municipal services.

On behalf of the National Latino Education Institute (NLEI), I support Midwest Generation's request for temporary relief from regulations that prohibit reasonable accommodations to address air emissions reductions from the company's plants through the year 2019.

Midwest Generation requests permission to reduce, not eliminate, spending on environmental improvements for two years during the 12-year emissions reduction program. It is my understanding that the company has been meeting all of its environmental commitments under state regulations and, even with the variance, would meet all requirements by the time the state program ends in 2019.

Midwest Generation employs over 800 men and women—many of whom are union members, and provides jobs for hundreds of building and construction tradespeople. Annually, the company spends nearly \$400 million on Illinois goods and services and \$5 million on local property taxes. Equally important, Midwest Generation has a deeply rooted sense of social responsibility. 



The Waukegan Harbor Citizens' Advisory Group, representing the Waukegan Harbor Area of Concern and Extended Area of Concern, is supportive of Midwest Generation's request for a variance for temporary relief from the agreement time table adopted with the Illinois Environmental Protection Agency for Combined Pollutant Standards in 2007 while they work through financial restructuring. We understand that they will be reducing sulfur emissions each year beginning in 2013, as agreed upon during their restructuring process.

Midwest Generation has been an excellent corporate partner of the Waukegan Harbor CAG, Chicago Wilderness and the Waukegan community, especially the School District and Park District. They have always kept us completely informed of the plant updates, especially the recapture technology installed for NOX gases and Mercury, and the ongoing work to install the Sulfur recapture equipment which we fully supported and encouraged.

They were at the table early on to work with the Lake Michigan Forum on the Lake Michigan Lakewide Management Plan (LaMP) to reduce air emissions over the Lake Michigan Watershed, and to establish a leadership role in recapture technology for use locally, regionally, nationally and globally.

They met with our partner from Lake Baikal for a full site tour and discussions on how to transmit this new technology to plants overseas. This is an opportunity for the U.S. recapture technology to be utilized effectively on a global basis. To shut down the process just as we are nearing completion would be a negation of the past accomplishments. The USEPA indicates that 70% of the sulfur emissions crossing the USA are from off shore sources west of the continental USA. Midwest Generation emission reduction installations are reducing USA air emissions and working towards global reductions in the long term.

Midwest Generation is a partner in our Great Lakes Restoration Grant (\$1.433 million) for the Waukegan Dunal Area restoration to protect the buffer areas of Illinois Beach State Park, and is providing the access for very careful monitoring and documenting the extremely high floristic community and avian communities present on their property.

We recognize that with a membership as large and diverse as ours that all members may not be in agreement, but most of our members wish to continue working with Midwest Generation cooperatively as the company works through the financial restructuring. It is in the best long term interest of all parties concerned to work out the problems together, and not raise cause further difficulties and litigation. As a Recovering Environmental Justice Community, Waukegan does not need more litigation. They do need the new technology, and the jobs and revenue it brings.


