## HEARING OFFICER ORDER

On March 14, 2013, all parties participated in a telephonic status conference with the hearing officer. The attorney for the Village of Hinsdale stated that it will forward a draft settlement proposal to complainant within the next 10 days. The draft will not include the 55<sup>th</sup> Street issue. Complainant stated that it is still in discussions with the school district regarding the 55<sup>th</sup> Street issue. Both parties state that they will hold meetings with the complainant prior to the next status conference discussing discovery matters and a possible resolve.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on May 23, 2013, at 11:30 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. The complainant represented that it will notify the parties and the hearing officer of a call-in number prior to the next telephonic status conference. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
