
HEARING OFFICER ORDER

On April 25, 2013, all parties participated in a telephonic status conference with the hearing officer. The complainant stated that the parties are close to a settlement. While the penalty amount is agreed to, the parties are still discussing future compliance terms.

The complainant requested that an agreed oral extension to June 14, 2013, be granted that would allow respondent to respond to complainant's motion to deem facts admitted and motion for summary judgment, filed January 31, 2013. Complainant's request is granted and the respondent must file its responses, if needed, on or before June 14, 2013.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on May 28, 2013, at 9:00 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a stipulation and proposal for settlement is filed prior to the next status conference, the conference will be cancelled without further notice.


