- 1. On April 8, 2013, Petitioner filed a Petition for Review ("Petition") of the ("CAAPP") permit (No. 96030056) ("Permit") issued to Petitioner, on March 4, 2013, by the Illinois Environmental Protection Agency ("Illinois EPA") for Petitioner's integrated steel mill plant located in Granite City, Illinois
