
HEARING OFFICER ORDER

On May 9, 2017, Johns Manville (JM) filed its response to the Illinois Department of Transportation's (IDOT) motion to compel. On May 16, 2017, IDOT filed its reply. In JM's response, it states that a Supreme Court Rule 214 certification has been provided to IDOT and therefore IDOT's motion is moot. Resp. at 3. In IDOT's reply, IDOT argues that the affidavit provided by JM is insufficient. Reply at 1-3.

A copy of the Supreme Court Rule 214 affidavit has not been filed with the Clerk of the Board nor has it been served on me. JM is directed to file a copy of the affidavit with the Board and serve me with a copy on or before May 19, 2017.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on May 25, 2017, at 10:00 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance.

IT IS SO ORDERED.




