NOTICE OF LIMITED WAIVER OF 120-DAY DECISION DEADLINE

NOW COMES Petitioner, UNITED STATES STEEL CORPORATION (“Petitioner”), by and through its attorneys, HEPLERBROOM, LLC, pursuant to 35 Ill. Admin. Code § 101.308(c)(2), and hereby agrees to a limited waiver of the statutory 120-day decision deadline for final action by the Illinois Pollution Control Board (“Board”) in this proceeding until June 30, 2018. In support of this Notice, Petitioner states as follows:

1. On April 8, 2013, Petitioner filed a Petition for Review (“Petition”) of the (“CAAPP”) permit (No. 96030056) (“Permit”) issued to Petitioner, on March 4, 2013, by the Illinois Environmental Protection Agency (“Illinois EPA”) for Petitioner’s integrated steel mill plant located in Granite City, Illinois

2. On April 18, 2013, the Board accepted Petitioner’s Petition for hearing. Board Order, *United States Steel Corporation v. Illinois EPA*, PCB No. 13-53 (Ill.Pol.Control.Bd. Apr. 18, 2013).

3. The current decision deadline for this matter is December 31, 2017.

4. Petitioner hereby voluntarily agrees to a limited waiver of the statutory 120-day decision deadline until June 30, 2018.

WHEREFORE, Petitioner, UNITED STATES STEEL CORPORATION, prays that the Illinois Pollution Control Board accept this limited waiver of the statutory 120-day decision deadline for final action on Petitioner's Petition for Review.
