In conformance with the requirements of Rule 101.112(b) of the Illinois Pollution Control Board Rules, 35 Ill. Adm. Code 101.112(b) and Rule 1.12 of the Illinois Rules of Professional Conduct, notice is hereby given that on September 1, 2017, Daniel Robertson began working as an Assistant Attorney General for the Office of the Illinois Attorney General (“AGO”) in the Environmental Bureau in Chicago (“EBN”).

Prior to joining the EBN, during the period beginning March 2010 and continuing through June 30, 2017, AAG Robertson worked as an Attorney Advisor to Jennifer Burke, a former Board Member on the Illinois Pollution Control Board (“Board”), who was the assigned Board Member for *Johns Manville v. Illinois Department of Transportation*, PCB 14-3 (Citizen Suit) (“Case”), a case currently pending before the Board. AAG Robertson resigned from the Board effective August 31, 2017.

Because of AAG Robertson’s former duties as an Assistant Advisor to former Board Member Burke and his involvement in the Case, the management of the EBN has required AAG Robertson to adhere to certain screening protocols (“Screening Protocols”) that prohibit him from: 1) working in any way on the Case; 2) speaking about the Case and/or AAG Robertson’s

prior involvement in the Case with anyone employed by the AGO, including the EBN; and, 3)
accessing any files or information maintained by the EBN related to the Case.
