MOTION TO VOLUNTARILY DISMISS

NOW COMES Petitioner, Midwest Electric Power, Inc., by and through its attorneys, Schiff Hardin LLP, and pursuant to Section 101.500 of the Illinois Pollution Control Board's (Board's) procedural rules and moves the Board to dismiss this Clean Air Act Permit Program (CAAPP) permit appeal and close the docket, stating as follows:

1. On April 23, 2009, Ameren Energy Generating Company, Electric Energy, Inc., and Midwest Electric Power, Inc. (Petitioners) filed a Petition for Review of CAAPP Permit No. 01050058 issued by the Illinois Environmental Protection Agency to Midwest Electric Power, Inc. and a request for a stay of the contested conditions.
2. On July 23, 2009, the Board stayed the effectiveness of the contested conditions pending the final resolution of the appeal.
3. On October 16, 2014, the Board granted Petitioners' motion to strike Ameren Electric Generating Company from this matter.
4. The parties came to an agreement about the issues raised in the appeal.

5. Petitioner Midwest Electric Power, Inc. received a final modified CAAPP permit, issued August 14, 2017, addressing the issues raised in the appeal.

WHEREFORE, Midwest Electric Power, Inc. moves the Board to grant the Motion to Voluntarily Dismiss, dismiss this appeal, and close the docket.
