HEARING OFFICER ORDER


On January 9, 2018, a telephonic status conference was held. The complainant again failed to appear. The respondent stated that it has attempted on numerous occasions to contact the complainant in the last 45-50 days for settlement discussions. *See* Hearing Officer orders, November 14, 2017 and December 18, 2017. To date, respondent has been unable to contact the complainant. On January 9, 2018, the respondent provided me with complainant’s telephone numbers and her e-mail address. I attempted to contact her by telephone and her e-mail address. To date, complainant has not responded.

The respondent anticipates filing a motion to dismiss prior to the next scheduled telephonic status conference.

Any deadlines for answering the request to admit or responding to the outstanding motions, including responding to respondent’s motions for clarification and reconsideration filed August 24 and 25, 2016, are stayed.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on January 24, 2018, at 11:00 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


