

JURISDICTION

This Administrative Citation is issued pursuant to the authority vested in the Illinois Environmental Protection Agency by Section 31.1 of the Illinois Environmental Protection Act, 415 ILCS 5/31.1 (2014).

FACTS

1. That The Estate of Craig S. Walker is the owner and Walker & Sons Enterprises, LTD is the current operator ("Respondents") of a facility located at 421 East Monetta, Peoria Heights, Peoria County, Illinois. The property is commonly known to the Illinois Environmental Protection Agency as Walker & Sons.
2. That said facility is designated with Site Code No. 1430703003.
3. That Respondents have owned said facility at all times pertinent hereto.
4. That on March 6, 2018, Gerald McGhee of the Illinois Environmental Protection Agency's ("Illinois EPA") Peoria Regional Office inspected the above-described facility. A copy of the inspection report setting forth the results of said inspection is attached hereto and made a part hereof.

5. That on April 30, 2018, Illinois EPA sent this Administrative Citation to The Estate of Craig S. Walker via Certified Mail No. 7017 2680 0001 0214 6500, and to Walker & Sons Enterprises, LTD via Certified Mail No.

7017 2680 0001 0214 6517.

#### VIOLATIONS

Based upon direct observations made by Gerald McGhee during the course of the March 6, 2018 inspection of the above-named facility, the Illinois Environmental Protection Agency has determined that Respondents have violated the Illinois Environmental Protection Act (hereinafter, the "Act") as follows:

- (1) That Respondents caused or allowed the open dumping of waste in a manner resulting in litter, a violation of Section 21(p)(1) of the Act, 415 ILCS 5/21(p)(1) (2014).
- (2) That Respondents caused or allowed water to accumulate in used or waste tires, a violation of Section 55(k)(1) of the Act, 415 ILCS 55(k)(1) (2014).

#### CIVIL PENALTY

Pursuant to Section 42(b)(4-5) of the Act, 415 ILCS 5/42(b)(4-5) (2014), Respondents are subject to a civil penalty of One Thousand Five Hundred Dollars (\$1,500.00) for each of the violations identified above, for a total of Three Thousand Dollars (\$3,000.00). If Respondents elect not to petition the Illinois Pollution Control Board, the statutory civil penalty specified above shall be due and payable no later than June 11, 2018, unless otherwise provided by order of the Illinois Pollution Control Board.

If Respondents elect to contest this Administrative Citation by petitioning the Illinois Pollution Control Board in accordance with Section 31.1 of the Act, 415 ILCS 5/31.1 (2014), and if the Illinois Pollution Control Board issues a finding of violation as alleged herein, after an adjudicatory hearing,

Respondents shall be assessed the associated hearing costs incurred by the Illinois Environmental Protection Agency and the Illinois Pollution Control Board. Those hearing costs shall be assessed in addition to the One Thousand Five Hundred Dollar (\$1,500.00) statutory civil penalty for each violation.

Pursuant to Section 31.1(d)(1) of the Act, 415 ILCS 5/31.1(d)(1)(2014), if Respondents fail to petition or elect not to petition the Illinois Pollution Control Board for review of this Administrative Citation within thirty-five (35) days of the date of service, the Illinois Pollution Control Board shall adopt a final order, which shall include this Administrative Citation and findings of violation as alleged herein, and shall impose the statutory civil penalty specified above.

When payment is made, Respondents' check shall be made payable to the Illinois Environmental Protection Trust Fund and mailed to the attention of Fiscal Services, Illinois Environmental Protection Agency, 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276. Along with payment, Respondents shall complete and return the enclosed Remittance Form to ensure proper documentation of payment.

If any civil penalty and/or hearing costs are not paid within the time prescribed by order of the Illinois Pollution Control Board, interest on said penalty and/or hearing costs shall be assessed against the Respondents from the date payment is due up to and including the date that payment is received. The Office of the Illinois Attorney General may be requested to initiate proceedings against Respondents in Circuit Court to collect said penalty and/or hearing costs, plus any interest accrued.

PROCEDURE FOR CONTESTING THIS  
ADMINISTRATIVE CITATION

Respondents have the right to contest this Administrative Citation pursuant to and in accordance with Section 31.1 of the Act, 415 ILCS 5/31/1 (2014). If Respondents elect to contest this Administrative Citation, then Respondents shall file a signed Petition for Review, including a Notice of Filing, Certificate of Service, and Notice of Appearance, with the Clerk of the Illinois Pollution Control Board, State of Illinois Center, 100 West Randolph, Suite 11-500, Chicago, Illinois 60601. A copy of said Petition for Review shall be filed with the Illinois Environmental Protection Agency's Division of Legal Counsel at 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276. Section 31.1 of the Act provides that any Petition for Review shall be filed within thirty-five (35) days of the date of service of this Administrative Citation or the Illinois Pollution Control Board shall enter a default judgment against the Respondents.

**Executive Summary**

On March 6, 2018, Jeb McGhee, BOL/FOS – Peoria conducted an inspection from 0955 – 1025 hrs at Walker & Sons located at 421 E. Moneta Street, in Peoria Heights, Illinois. The facility is owned by the Estate of Craig S. Walker. Mathew Ryan Walker is the executor of the Estate. The facility is operated by Brandon Walker who also resides at the facility was interviewed during the inspection. The inspection was conducted as a follow to an Administrative Citation Warning Notice (ACWN) sent to Mathew Walker and Brandon Walker on January 18, 2018 citing apparent violations, involving storage of used oil, and storage and transportation of used tires. Neither Mathew Walker or Brandon Walker responded in writing to the ACWN. The compliance deadline was March 1, 2018. All apparent violations are continuing.

**Inspection Narrative**

I observed about 450 used tires at the facility. Used tires are not prevented from accumulating water as seen in photographs 3, 7, and 9. Piles of used tires stored outside are not separated by a firebreak of 40 feet of other piles of tires; by a firebreak of 50 feet of buildings on or off site; by a firebreak of 50 feet of all the sites property boundaries; by a firebreak of 100 feet of trees; and by a firebreak of 40 feet of grass, weeds, brush, and combustible vegetation. See photographs 1, 2, 4, 5, 6, 8, 12, 13, and 14.

I did not observe above ground containers holding used oil. Mr. Walker would not open building doors or allow me to enter the building(s) to verify compliance.

The facility remains an unregistered Tire Storage Site containing over 50 used tires. The Used and/or Waste Tire Activity Notification Form and Registration Fee have not been paid for the years 2017 and now 2018.

Mr. Walker explained that he puts tires from automobiles back inside the autos and transports the automobile to Allied Iron & Steel in Peoria, Illinois for scrapping. Mr. Walker could not produce tire tracking receipts for removal of any tires from the facility.






