JURISDICTION

This Administrative Citation is issued pursuant to the authority vested in the Macon County Environmental Management Department, a delegated county of the Illinois Environmental Protection Agency by Section 31.1 of the Illinois Environmental Protection Act , 415 ILCS 5/31.1.

FACTS

1. That on April 11, 2018, Laurie Rasmus of the Macon County Environmental Management Department inspected the above-referenced facility. A copy of her inspection report setting forth the results of said inspection is attached hereto and made a part hereof.

VIOLATIONS

Based upon direct observations made by Laurie Rasmus during the course of her inspection of the above-referenced facility, the Macon County Environmental Management Department has determined that Respondent violated the Illinois Environmental Protection Act (hereinafter, the "Act") as follows:

- (1) That Respondent caused or allowed open dumping of waste in a manner resulting in litter, a violation of Section 21(p)(1) of the Act, 415 ILCS 5/21(p)(1).

#### CIVIL PENALTY

Pursuant to Section 42(b)(4) of the Act, 415 ILCS 5/42(b)(4), Respondent is subject to a civil penalty of One Thousand Five Hundred Dollars (\$1,500.00) for each of the violations identified above, for a total of One Thousand Five Hundred Dollars (\$1,500). If Respondent elects not to petition the Illinois Pollution Control Board, the statutory civil penalty specified above shall be due and payable no later than June 29, 2018, unless otherwise provided by order of the Illinois Pollution Control Board.

If Respondent elects to contest this Administrative Citation by petitioning the Illinois Pollution Control Board in accordance with Section 31.1 of the Act, 415 ILCS 5/31.1, and if the Illinois Pollution Control Board issues a finding of violation(s) as alleged herein, after an adjudicatory hearing, Respondent shall be assessed the associated hearing costs incurred by the Macon County Environmental Management Department and the Illinois Pollution Control Board. Those hearing costs shall be assessed in addition to the statutory civil penalty of One Thousand Five Hundred Dollars (\$1,500.00).

Pursuant to Section 31.1(d)(1) of the Act, 415 ILCS 5/31.1(d)(1), if Respondent fails to petition or elects not to petition the Illinois Pollution Control Board for review of this Administrative Citation within thirty-five (35) days of the date of service, the Illinois Pollution Control Board shall adopt a final order, which shall include this Administrative Citation and a

finding of violation(s) as alleged herein, and shall impose the statutory civil penalty specified above.

When payment is made, Respondent's checks shall be made payable in equal amounts (50% of total penalty each) to:

(1) Macon County Environmental Management Department and mailed to Macon County Environmental Management Department, 141 South Main Street, Room 408, Decatur, Illinois 62523.

(2) Illinois Environmental Protection Trust Fund and mailed to the attention of Fiscal Services, Illinois Environmental Protection Agency, 1021 North Grand Avenue East, P.O. Box 19276, Springfield, Illinois 62794-9276.

Along with payments, Respondent shall complete and return the enclosed Remittance Forms to ensure proper documentation of payments.

If any civil penalty and/or hearing costs are not paid within the time prescribed by order of the Illinois Pollution Control Board, interest on said penalty and/or hearing costs shall be assessed against the Respondent from the date payment is due up to and including the date that payment is received. The Office of the Macon County State's Attorney may be requested to initiate proceedings against Respondent in Circuit Court to collect said penalty and/or hearing costs, plus any interest accrued.

PROCEDURE FOR CONTESTING THIS  
ADMINISTRATIVE CITATION

Respondent has the right to contest this Administrative Citation pursuant to and in accordance with Section 31.1 of the Act, 415 ILCS 5/31.1. If Respondent elects to contest this Administrative Citation, then Respondent shall file a signed Petition for Review, including a Notice of Filing, Certificate of Service, and Notice of Appearance, with the Clerk of the Illinois Pollution Control Board, State of Illinois Center, 100 West Randolph, Suite 11-500, Chicago,

Illinois 60601. A copy of said Petition for Review shall be filed with the Macon County State's Attorney at 253 East Wood Street, Decatur, Illinois 62523. Section 31.1 of the Act provides that any Petition for Review shall be filed within thirty-five (35) days of the date of service of this Administrative Citation or the Illinois Pollution Control Board shall enter a default judgment against the Respondent.

**Inspection Report Narrative**

This site was inspected on April 11, 2018 between 1:40 p.m. and 3:30 p.m. by Laurie Rasmus (author of this report), representing the Macon County Environmental Management Department (MCEMD). Weather conditions at the time of the inspection consisted of partly cloudy skies and air temperature near 55 degrees with south-southwest winds of approximately fifteen miles per hour. Eleven photographs were recorded at the site (photos 01 -11) and an additional photo (photo A) was recorded at another site, 1035 N. Dunham in Decatur. Two documents were taken (photos 02, 03). No persons were observed on site.

**General Information/Site History/Property Ownership**

This site is just north of the Sangamon River on the right of way of Lincoln Memorial Parkway, which is maintained by the Macon County Highway Department.

This initial inspection was conducted after receiving a report from the Macon County Highway Department on April 10, 2018 that open dumping had apparently occurred at the site.

**Inspection Findings**

Upon arrival, I parked along the west side of Lincoln Memorial Parkway approximately 150 feet north of the bridge over the Sangamon River. I then walked the area between my vehicle and the bridge and down the ditch to the west.

Accumulations of waste and litter appeared to have been open dumped in the area (photos 01 – 11). Waste items that appeared to have been disposed included weathered dimensional lumber, woody landscape waste, a damaged coffee table, a coffee maker box, a camp fuel can, an Olive Garden bag with garbage, school papers, a Pedigree Adult dog food bag, water bottles with County Market, Dansi and other labels, diapers that appeared to be soiled, a toy plastic watch, a toy plastic horseshoe, an Agro hydroponic seed starter bag, a plastic tub, plastic tubing, a dispenser of the type that are coin operated and typically in a public restroom and no less than two waste tires of which at least one contained an accumulation of water. Among an accumulation of waste (photos 01, 04) that was nearby the road were two addressed documents, each inside of an envelope with a clear window and apparently disposed of. Each of the documents were addressed to 1035 N. Dunham, Decatur. The first document (photo

02) was a check addressed to Jennifer Reynolds and dated November 21, 2016. The second document did not appear to be dated but was addressed to Amanda Maple.

Following my observations, I returned to my vehicle and drove from the site.

Later in the afternoon, with the accompaniment of Deputy D. Lambdin of the Macon County Sheriff's Office, I visited the residence at 1035 N. Dunham in Decatur. Deputy Lambdin knocked on the door and windows of the residence but no response was received and no persons were seen on the property. Three empty trash containers were at the curb in front of the residence (photo A). The trash containers were not of the type that are distributed by a waste hauler. Other residences along the street had 96 gallon wheel toters, labeled with Advanced Disposal's logo/name, at the curb. Before Deputy Lambdin and I drove from the address, Deputy Lambdin said that he would stop back at the address before the end of his shift.

### **Post-Inspection Findings**

On April 12, 2018, I listened to a voice message from Deputy Lambdin, saying that he had made a second visit to 1035 N. Dunham and again did not find any one at home. In the message, he went on to say that he spoke with someone in the area and was told that Tiffany Maple lives at the address along with her two children and has lived there for the past five years.

In email responses from Advanced Disposal on April 12, 2018, I learned that Tiffany Maple is the account holder for the waste services at 1035 N. Dunham and that ADS is scheduled to service the residence on Tuesdays.

### **Summary of Apparent Violations**

**Environmental Protection Act 415 ILCS 5/1 et seq.** (formerly Ill Rev. Stat. Ch. 111 ½, 1001 et seq.) {hereinafter referred to as the "Act"} and **35 Illinois Administrative Code.** (Title 35: Environmental Protection, Subtitle G: Land Pollution, Chapter I: Pollution Control Board) [Regulations]

**Pursuant to Section 21(a) of the Act,** no person shall cause or allow the open dumping of any waste.

A violation of Section 21(a) is alleged because evidence of open dumping of waste was observed during the inspection.

**Pursuant to Section 21(d)(1) of the Act,** in relevant part, no person shall conduct any waste-storage, waste-treatment, or waste-disposal operation without a permit granted by the Agency or in violation of any conditions imposed by such permit, including periodic reports and full access to adequate records and the inspection of facilities, as

may be necessary to assure compliance with this Act and with regulations and standards adopted there under.

A violation of Section 21(d)(1) is alleged because evidence that waste was disposed of and/or stored without a permit granted by the Agency was observed during the inspection.

**Pursuant to Section 21(d)(2) of the Act**, no person shall conduct any waste-storage, waste-treatment, or waste-disposal operation in violation of any regulations or standards adopted by the Board under this Act.

A violation of Section 21(d)(2) is alleged because evidence that waste was disposed of and/or stored in a way that violates regulations and standards adopted by the Board was observed during the inspection.

**Pursuant to Section 21(e) of the Act**, no person shall dispose, treat, store or abandon any waste, or transport any waste into this State for disposal, treatment, storage or abandonment, except at a site or facility which meets the requirements of this Act and of regulations and standards there under.

A violation of Section 21(e) is alleged because evidence that waste was disposed of and/or stored in a manner that does not meet the requirements of the Act was observed during the inspection.

**Pursuant to Section 21(p)(1) of the Act**, no person shall cause or allow the open dumping of any waste in a manner which results in any of the following occurrences at the dump site...litter.

A violation of Section 21(p)(1) is alleged because evidence that open dumping of waste was caused or allowed to occur and resulted in litter deposition on site was observed during the inspection.

**Pursuant to Section 55(a), (1) of the Act**, no person shall cause or allow open dumping of any used or waste tire.

A violation of Section 55(a), (1) is alleged because evidence that waste tires were open-dumped on the site was observed during the inspection.

**Pursuant to Section 55(a), (2) of the Act**, no person shall cause or allow open burning of any used or waste tire.

A violation of Section 55(a), (2) is alleged because evidence that waste tires were open-burned on the site was observed during the inspection.

**Pursuant to Section 55(k), (1) of the Act**, no person shall cause or allow water to accumulate in used or waste tires.

A violation of Section 55(k), (1) is alleged because water was allowed to accumulate in no less than one used or waste tire.
