#### **Rulemaking Update**

#### Board Closes Subdocket on Groundwater Monitoring for CCDD Fill Operations, R12-9(B)

On August 6, 2015, the Board adopted an opinion and order in the rulemaking captioned <u>Proposed Amendments to Clean Construction or Demolition Debris (CCDD) Fill Operations:</u> <u>Proposed Amendments to 35 Ill. Adm. Code 1100</u>, docket R12-9(B). On July 29, 2011, the Illinois Environmental Protection Agency (IEPA) initiated this rulemaking by filing a proposal pursuant to Sections 22.51 and 22.51a of the Environmental Protection Act (415 ILCS 5/22.51, 22.51a). The proposal sought rule amendments that would allow uncontaminated clean construction or demolition debris (CCDD) and uncontaminated soil to be used as fill at quarries, mines, and other excavations. On August 23, 2012, the Board adopted final amendments to its rules, but declined to require groundwater monitoring at permitted CCDD facilities or at uncontaminated soil fill sites. However, as recommended by the Joint Committee on Administrative Rules (JCAR), the Board opened subdocket B to further examine whether groundwater monitoring should be required. After reviewing the extensive additional comment and testimony received, the Board determined that the record still failed to demonstrate that groundwater monitoring was necessary at these locations to protect groundwater. Therefore, the Board closed subdocket B.

# **Board Clarifies Difference between Effective Date and Future Compliance Date for Chloride and Temperature Water Quality Standards, R08-9(D)**

On August 20, 2015, the Board issued an order granting IEPA's motion for clarification in the rulemaking captioned <u>Water Quality Standards and Effluent Limitations for the Chicago Area</u> <u>Waterway System [CAWS] and Lower Des Plaines River [LDPR]: Proposed Amendments to 35</u> <u>Ill. Adm. Code 301, 302, 303, and 304</u>, docket R08-9(D). In its order, the Board explained that the rules adopted through its opinion and order of June 18, 2015, became effective on July 1, 2015. The Board had specified the July 1, 2015 effective date on the notice pages previously filed with the Secretary of State. Although the rules do include water quality standards for chloride and temperature that became applicable on July 1, 2015, the rules also include more stringent water quality standards for chloride and temperature that will become applicable three years later—on July 1, 2018. Such a future compliance date set forth in a rule, however, does not alter when the rule become effective. Under the Illinois Administrative Procedure Act (5 ILCS 100/5-40(d)), rules become effective upon filing with the Secretary of State, unless a later effective date is required by statute or specified in the rulemaking. The Board granted IEPA's motion to clarify and reiterated that the rules here took effect on July 1, 2015.

IEPA sought clarification as to the effective date because numerous entities had filed petitions with the Board for variances from the water quality standards. Under Section 38(b) of the Environmental Protection Act (415 ILCS 5/38(b)), if a person files a petition for a variance from a rule within 20 days after the rule's effective date, the operation of the rule is stayed as to the person, pending disposition of the petition.

Before the Board turned to IEPA's motion to clarify, the Board noted that the Salt Institute—on July 23, 2016—appealed the chloride water quality standard to the First District Appellate Court (<u>Salt Institute v. Illinois Pollution Control Board</u>, No. 1-15-2003). The Board recognized that even though the court acquired jurisdiction upon receiving the Salt Institute's petition for review, the Board retained jurisdiction to rule upon IEPA's motion for clarification because the motion involved matters collateral or incidental to the Board decision on appeal.

# **Board Adopts "Identical-In-Substance" Amendments for Wastewater Pretreatment Update, R15-13**

On August 20, 2015, the Board adopted final amendments to the Illinois regulations that are "identical-in-substance" to wastewater pretreatment regulations adopted by the United States Environmental Protection Agency (USEPA). The Board's rulemaking is captioned <u>Wastewater Pretreatment Update, USEPA Amendments (July 1, 2014 through December 31, 2014)</u>, docket R15-13. The amendments update an "incorporation by reference" of the federal provision concerning appropriate methods for Clean Water Act analyses. On August 19, 2014, USEPA instituted a requirement to select only "sufficiently sensitive" methods for such analyses. This is not a wastewater pretreatment program. In addition, as a routine matter, the adopted amendments update—to the 2014 edition—all incorporations by reference to USEPA regulations and federal statutes. The amendments also move an incorporation by reference—of a USEPA rule that helps define "toxic pollutant"—from 35 Ill. Adm. Code 307.1005 to the centralized listing of incorporations by reference for the wastewater pretreatment program at 35 Ill. Adm. Code 310.107.

#### Board Proposes "Identical-In-Substance" Amendments for SDWA Update, R16-4

On August 20, 2015, the Board proposed for public comment amendments to the Illinois regulations that are "identical-in-substance" to drinking water regulations adopted by USEPA under the Safe Drinking Water Act (SDWA). The Board's rulemaking is captioned <u>SDWA</u> <u>Update, USEPA Amendments (January 1, 2015 through June 30, 2015)</u>, docket R16-4. The proposed amendments do not include any direct USEPA actions with regard to the National Primary Drinking Water Regulations during the first half of 2015 because no such actions occurred. Instead, the proposal would make needed corrections to the existing rules to accommodate suggestions from JCAR and IEPA, as well as corrections initiated by the Board. JCAR staff's suggestions, which concern limited minor errors in the text of the Illinois rules, were made during the course of the last SDWA update in docket R15-2. And, in a recently-filed rulemaking docketed as R15-23, IEPA pointed out segments of the public notification provisions of the rules that refer to the federal secondary maximum contaminant limit (MCL) for fluoride, which the Board removed from the Illinois rules several years ago. Finally, the Board proposes to correct the spelling of "exceedence" to "exceedance" where this appears in various segments of the rules.

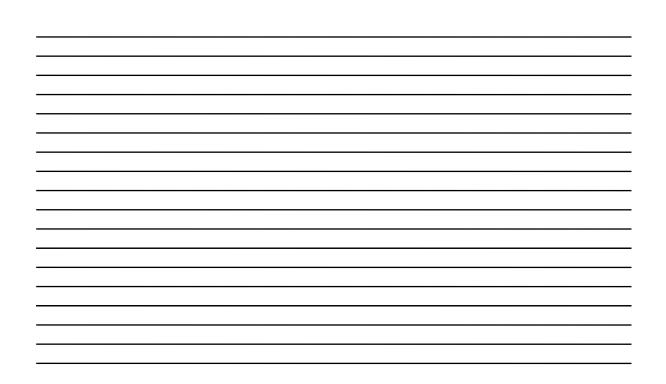
