

PETITION TO REVIEW ADMINISTRATIVE CITATION

NOW COMES Respondent, Daniel Dawson, hereby requests a review of the Administrative Citation ("AC") issued by Complainant, ILLINOIS ENVIRONMENTAL PROTECTION AGENCY ("IEPA"), in the above-entitled case and in support thereof, states as follows:

1. On or about April 8, 2013, Dustin Burger, field inspector for the IEPA, went to the Respondent's residence located at 13358 E 75 North Rd, in Heyworth, IL, after receiving a complaint alleging illegal dumping and burning on said property. Mr. Burger was allowed to inspect, and made the respondent's wife ("Mrs. Dawson") aware of the presence of violations.

2. On or about July 5, 2013, the respondent made an effort to clear the site in accordance with the violations that were stated in the IEPA Open Dump Inspection Checklist mailed to him on April 24, 2013. The respondent was not aware that Mr. Burger had performed a reinspection on July 2, 2013.

3. As stated in the Narrative Inspection Report submitted by Mr. Burger, when he conducted his reinspection on July 2, 2013, no one was home and he observed no new evidence of continued burning or dumping at the sight. Respondent believes this observation supports his claim that he was attempting to comply with the order and statutes regarding this site after being made aware of them.

4. On or about August 22, 2013, Mr. Burger went to the respondent's residence and presented Mrs. Dawson with the above referenced AC and accompanying documents. At that time, Mrs. Dawson informed Mr. Burger the site had been cleaned up. Mr. Burger was allowed to reinspect. He presented Mrs. Dawson with digital images on his phone of a few items which were not completed in a satisfactory manner.

5. On August 23, 2013, the respondent cleared the remaining debris as instructed by Mr. Burger, and forwarded digital images of the completely cleared site to him by email at Dustin.Burger@illinois.gov

WHEREFORE, as the respondent, Daniel Dawson, has now fully complied with the Illinois Environmental Protection Agency's order to clear the site, the respondent requests that the Illinois Pollution Control Board enter an order dismissing the Administrative Citation, and denying the civil penalties and other relief sought therein.

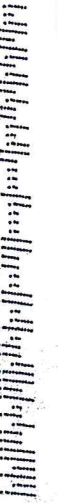
