Now comes FLOSSIE E. HAYES and KEVIN E.STINE, by their attorney, Ronald D. Young, and Petitions for Review the Administrative Citation of the IEPA dated August 26, 2013 and states as follows:

- 1. This proceeding concerns a property located at 109 Broadway Street, Iola, Illinois
- 2. The said property is designated with Site Code No. 0250150004.
- 3. A field inspector for the Illinois Environmental Protection Agency (Garrison Gross) inspected the property on July 17, 2013 and alleges Respondents violated Sections 21(p)(1) and 21(p)(7) of the Environmental Protection Act 415 ILCS.
- 4. Named Respondent, Kevin E. Stine, does not own the property and did not cause or allow the alleged violations. Kevin E. Stine merely maintained weed control on the property.
 - 5. Named Respondent, Flossie E. Hayes, is the owner of the property.
- 6. Mrs. Hayes did contact a licensed asbestos disposal agent to have that company properly dispose of the construction debris in October of 2012.

7. The contractor, Triple A Asbestos of Pana, Illinois was delayed in providing the removal due to weather conditions and scheduling due number of asbestos removal jobs

8. The delay in removal was beyond the control of the Respondent, Flossie E. Hayes.

9. Triple A Asbestos was able to do the property clean-up and disposal on September 18, 2013 and did report the compliance to Garrison Gross. Exhibits A and B, C and D attached.

Wherefore, Respondent Kevin E. Stine asks that the Administration Citation against him be dismissed. Mr. Stine was not an owner and did not cause the violation.

Respondent Flossie E. Hayes asks the Board to consider the statements of this petition and dismiss the Administrative Citation against her and vacate the penalty




