

NOW COMES the Complainant, the Illinois Environmental Protection Agency ("Illinois EPA"), by and through its attorney, Assistant Counsel Michelle M. Ryan, pursuant to 35 Ill. Adm. Code 101.500, and respectfully states as follows:

(1) On October 10, 2013 , Illinois EPA issued an Administrative Citation to Respondent, Frank Root ("Respondent"), based on an inspection conducted on August 21, 2013.


(2) On November 27, 2013, Respondent filed an amended petition for review contesting this Administrative Citation.


