NOTICE OF PUBLIC HEARING

The Illinois Pollution Control Board gives notice of public hearing regarding rule changes proposed by the Board on March 20, 2014; National Ambient Air Quality Standards; USEPA Amendments July 1, 2013 through December 31, 2013; R14-17. If the Board adopts the rules, the Illinois Environmental Protection Agency (IEPA) will submit them to the United States Environmental Protection Agency (USEPA) as proposed revisions to the Illinois State Implementation Plan (SIP) for carbon monoxide, lead, nitrogen oxides, ozone, particulate matter, and sulfur oxides. The SIP contains Illinois requirements to attain and maintain National Ambient Air Quality Standards (NAAQS) to protect public health and the environment under the federal Clean Air Act and state Environmental Protection Act. The update is needed to ensure that Illinois' regulations reflect the USEPA's most recent NAAQS. Interested persons are invited to attend the hearings or to submit written comments. The Public Hearing will be held on May 7, 2014, at 1:30 p.m. at the Pollution Control Board Conference Room, James R. Thompson Center, 100 West Randolph Street, 11-500, Chicago, Illinois and Pollution Control Board Conference Room, Sangamo Building, 1021 North Grand Avenue, Springfield, Illinois. The hearing is subject to cancellation without notice and may be confirmed by calling the Office of the Clerk at 312/614-3461.
