



Notice of Petition by Cromwell-Phoenix, Inc. for an Adjusted Standard before the Illinois Pollution Control Board.

This publication is to provide notice that Cromwell-Phoenix, Inc., located at 12701 South Ridgeway Avenue in Alsip, Illinois 60803, has filed with the Illinois Pollution Control Board a Petition for an Adjusted Standard. The Petition for an Adjusted Standard was filed on May 29, 2003, and was assigned docket number AS 03-05. The Petition seeks an adjusted standard from 35 Ill. Adm. Code Subpart F, Section 218.204(c) (the "'Paper Coating Rule''), as this rule applies to the emissions of volatile organic material from Cromwell-Phoenix, Inc.'s operations in Alsip, Illinois. The Adjusted Standard would allow Cromwell-Phoenix, Inc. to utilize corrosion inhibiting solutions in its manufacturing process that exceed 2.3 pounds of volatile organic material per gallon of coating applied (excluding water).

Any person may cause a public hearing to be held in the above-described adjusted standard proceeding by filing a hearing request with the Illinois Pollution Control Board within 21 days after the date of the publication of this notice. The hearing request should clearly indicate the docket number for the adjusted standard proceedings, as found in this notice, and shall be mailed to the Clerk of the Board, Illinois Pollution Control Board, 100 West Randolph Street, Suite 11-500, Chicago, Illinois 60601.
