I HAVE GIVEN RECIEPTS FROM DUMPSTER COMPANY TO DONNA SHEHANE.

DONNA SHEHANE CAME OUT AND PHYSICALLY INSPECTED AND ALSO AGREED THAT THIS IS A NON ISSUE.(PLEASE CALL DONNA SHEHANE TO VERIFY THIS INFORMATION AT 815-987-7271 OR EMAIL donna.shehane@illinois.gov I LIVE OUT OF STATE IN TENNESSEE AND HAVE A WORK SCHEDULE THAT IS UNCONTROLLABLE THIS CLEARLY IS A TIMING ISSUE FROM(AUG 20 INSPECTION, TO MY DISPOSAL WITHIN THE SAME WEEK IN AUGUST TO GETTING SERVED CITATION A MONTH LATER SEPT.30 AND FIRST WEEK IOIN OCTOBER 2015.

ACCORDING TO ITEM D SECTION 108.206 I BELIEVE UNCONTROLABLE CIRCUMSTANCES APPLY TO MY SITUATION CONSIDERING I WORK OUT OF TOWN AND CANNOT PHYSICALLY BE THERE TO PREVENT PEOPLE PUTTING THESE THINGS LIKE TIRES ON MY PROPERTY . I HAVE PUT A CABLE UP AT HTE FRONT ENTRANCE AND MADE A BARRACADE AT THE BACK TO DISCOURAGE THIS FROM HAPPENING AGAIN.
