
HEARING OFFICER ORDER

On May 24, 2013, the complainant filed a motion for extension of time for respondent Midwest Environmental Consulting Services, Inc. (Midwest Environmental), to answer or otherwise respond to the complaint that was filed on March 29, 2013. The complainant states that it and Midwest Environmental have been engaged in substantive negotiations. The complainant further states that the motion for extension of time applies only to Midwest Environmental, and not respondent Universal Asbestos Removal, Inc.

To that end, the complainant's motion is granted to the extent that Midwest Environmental's answer or other response is now due to be filed on or before June 12, 2013.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on June 12, 2013, at 10:00 a.m. The telephonic conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


